LONDON, Nov 23: Liquidators to the collapsed Bank of Credit and Commerce International (BCCI) are on the verge of agreeing an out-of-court settlement of more than 245 million dollars (149 million pounds) from Saudi Arabia's largest commercial bank, The Financial Times reported Tuesday, says AFP.

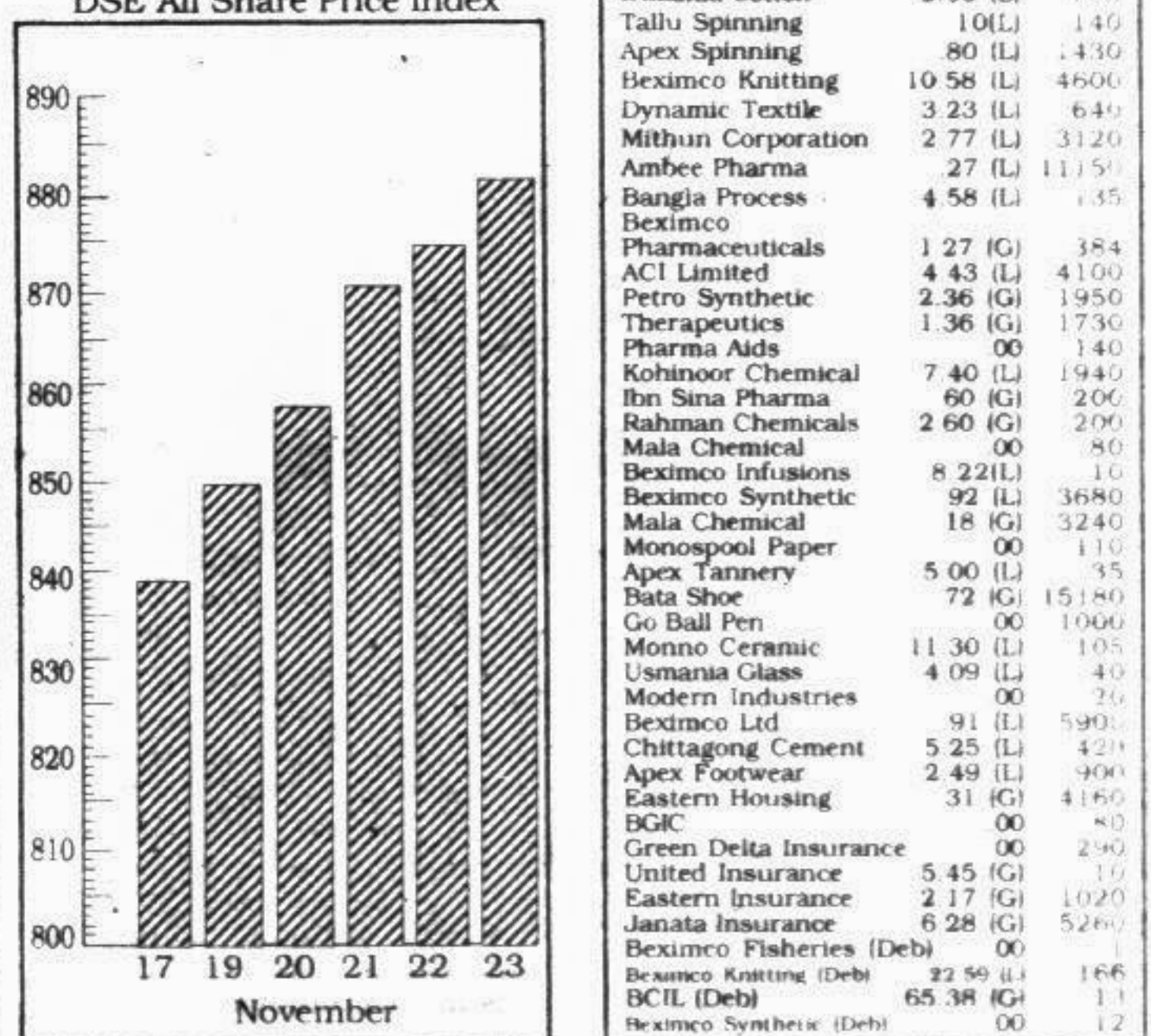
