"There is no alternative to a caretaker government to hold free and fair elections in the country," Hasina added.

The AL chief said the BNP came to power through an election held under a caretaker government but the same party is now terming the demand for a caretaker government 'illegal'

"Is the ruling party admitting its own illegitimacy by terming the caretaker government illegal?" she asked.

Hasina announced that if the AL came to power, it would incorporate the provision for caretaker governments in the Constitution.

She said the BNP was afraid of a caretaker government because it would be difficult for them to rig the elections.

The Leader of the Opposition alleged that the current session of Parliament was intentionally staggered to prevent the AL from holding meetings at its previously announced venue at the Pantha-

Hasina said staging walkouts during Parliament sessions is a democratic right of the opposition parties but the Leader of the House taunted us by saying that we were escaping like thieves' during our walkout.

She alleged that the ruling party had made Parliament meffective by ignoring the opposition parties.

Without mentioning any party or individual by name, Hasina said certain quarters were misinterpreting the Opposition decision of mass resignations.

She got an instant endorsement from the audience party decision. The slogan-chanting crowd raised their hands and gave her a goahead for further action programines.

Giving out a long list of failures of the government, she said the BNP government had even failed to realise the right share of the Ganges water.

On the other hand, the government sold out the interest of the country to neigh bouring India by signing an unequal agreement which prompted Delhi to push back so-called Bangladeshis to their homeland," she claimed.

Refuting the claims of massive development achieved by the BNP government, the AL chief said the 'development' centred around the PM, her family members and cabinet ministers.

Regarding the recent Ansars rebellion, Hasina said they had staged the agitation because the government had

fatled to implement the pledges made to them.

She pointed out that similar discontent is prevailing among the police force and the government employees.

Accusing the ruling party of

unleashing 'terrorism,' the Leader of the Opposition said more than 30 educational institutions were now closed because of hooliganism. She reminded her audience that not a single 'movement'

in this country had failed and

hoped that the people would succeed in the present strug-Hasina said she had nothing to lose because she had already lost her parents, broth-

alleged that conspiracies begin whenever the BNP is installed in power but this time such intrigues are bound to fail as the party still enjoys the people's mandate The rally was organised by

the city unit of the BNP at the 'Democracy Square' of Fulbaria area near Gulistan in the city in observance of December 6 as the "Downfall of Autocracy and Freedom of Democracy Day". On this day four years ago, president HM Ershad resigned in the wake of a mass agitation after nine years of autocratic rule.

The huge gathering was at tended by different units of the BNP and its front organisations from the city and suburbs and the people in general. The pro-government political activists started pouring in at the meeting venue carrying banners and placards and raising slogans since three in the afternoon and stayed there until evening to listen to the Prime Minister and other BNP leaders

About the Opposition's boycott of Parliament, the Leader of the House said their action was a sheer negligence of their sacred responsibilities entrusted them by the electorate. "They speak of democracy and public welfare but do not carry out their constitutional duties for which they took oath. The people no longer have any confidence in them."

Begum Zia said after being rejected by the people for their politics of destruction the opposition parties were now conspiring to unseat the elected government in collaboration with the fallen autocrats.

"People would not forgive those who have betrayed the martyrs of the anti-autocracy agitation whose supreme sacrifices helped restore democracy," she warned.

Pointing out that the 12th amendment to the Constitution, endorsed by all the parties in Parliament, had made it mandatory for elected representatives at all tiers of the government machinery, Begum Zia said there was no scope for unelected persons in the top position of the government. "But the Opposition is now proposing such an idea in contradiction of their earlier action," she said.

The Prime Minister urged her partners in the anti-autocracy movement to shun their politics of hartals and sieges that only hamper development and production and cause public suffering and instead practice democracy and abide by the Constitution.

"There are still chances to resolve the political crisis that you have created. Accept our proposal (for an interim government) to conduct elections if you are sincere about protecting the people's voting rights and believe in fair polls. she said, reiterating her call to the Opposition to return to the House for carrying out their

constitutional responsibilities. "Otherwise, the people who voted for you will not forgive you," she warned.

"We want no more problems

and are willing to solve the existing political standoff through dialogue and in accordance with the constitutional provisions," she said; adding that her party believed in democracy and that's why it

gave much concessions to the

Opposition. Reacting to the Opposition claim that no fair polls were possible under BNP rule, the Prime Minister asked how could the Opposition candidates win a number of parliamentary by-elections and the city corporation polls in Dhaka and Chittagong if those were not free and fair?

Mentioning her government's steps to strengthen the Election Commission and to introduce identity cards for the voters for ensuring a leakproof electoral system, the Prime Minister said, "no government in the past could take such a historic move.

"We have passed laws in the House in this regard because we want to guarantee the people's right to franchise."

Blasting the Opposition sponsored frequent hartals, blockades, barricades and sieges, the BNP chairperson remarked: "It is easy to call for such programmes. Such actions could be undertaken only by those who have no relation with the soil and its people and are opposed to development. "Despite repeated hartals, during the past three and a half years, the BNP had implemented numerous development projects and is continuing doing so," she said.

Begum Zia hoped that the Opposition would realise their misdeeds when they go back to the people.

Responding to AL chief Sheikh Hasina's warning to create a deadlock in the country if the Opposition demand was not met. Begum Zia said, "They themselves have now been placed in a deadlock. They will need the BNP's help to be mobile and come back to the people."

Rejecting once again the Opposition formula of a caretaker government to conduct general polls, Khaleda Zia said, "We were elected to power in a polls under the interim government of Justice Shahabuddin. We don't believe in the idea of a caretaker government which is purely unconstitutional," she said categorically.

Referring to the Jatiya Party's demand for the release of deposed president H M Ershad, the Prime Minister said "No thief could be fried so long the BNP remains in power."

Giving a list of her government's development activities in various fields, Begum Zia said the Opposition was adopting destructive measures because the BNP government had left no programmes on issues for them to campaign for.

"They are bringing charges of failure and inefficiency against the BNP government just to cover up their own failures while in power."

Defining 'native', the State Department says: "You are a native of the country in which you were born. You may also claim the country of birth of your spouse. You may claim the country of birth of your parents if you were born in a country in which neither parent was a native or resident at the time of your birth."

The official noted that in the case where country boundaries have changed since an applicant's birth, the 'native' country is the country of which his or her birth place is now a part. In the case of those born in India before partition, the native country could now be India, Pakistan or Bangladesh, depending on the birth place.

The visas will be issued in the US Fiscal Year 1996 (October 1, 1995 to September 30, 1996). Those who receive visas have four months in which to use them.

Visa space is allocated for the lottery based on visa patterns during the past five years in the six geographic areas of the world identified under the programme. Areas with lower immigration rates will get more lottery visas. High admission countries

are also determined by immigration patterns during the past five years. These patterns are reviewed each year. The official emphasized that

the data of five-year-patterns does not include persons who entered the United States through special visa programmes. The normal visa categories are: Immediate rela-
