

BRTC incurs Tk 295 cr loss

Facing stiff competition from the private buses as well as increasing losses, the Bangladesh Road Transport Corporation (BRTC) has been forced to close down most of its inter-district long route bus services.

BRTC sources said, since its inception in 1961, the total loss in this sole public transport sector stood at Taka 295 crore.

Over the years, widespread corruption, mismanagement and lack of responsibility of the workers and employees are the main causes for this colossal loss, they added.

Although as many as 2184 new buses and 1349 trucks were bought in the last two decades, the corporation incurred losses every year until 1993.

After selling out and cancelling the inoperative buses and trucks the total number of BRTC vehicles now stands at only 334. Among these, 127 are buses and 207 trucks.

Except for town services in Dhaka and Chittagong cities the BRTC is now operating its buses on a few inter-district routes only.

According to the sources, 50 double-decker buses are now plying in the two big cities. Among these 46 in Dhaka and 4 in Chittagong.

Among the inter-district routes in which BRTC buses are still operating are Dhaka-Narayanganj, Dhaka-Aricha, Dhaka-Bhuapore, Dhaka-Khagrachhari, and Barisal-Khulna. Except those routes, some BRTC buses are plying on remotest corners where private

bus cannot operate.

"Because BRTC is a public corporation, it has to keep services in some difficult routes for the greater interest of the people," a high-ranking official of the BRTC told The Daily Star.

He said, due to stern action against corruption and mismanagement, the income of the corporation has increased significantly last year. According to him for the first time BRTC made profit of about Taka 2.21 crore during the period from October 1993 to August '94.

Necessary actions have already been taken recently to reduce the loss and make the corporation profitable and viable.

Among the measures, reduction of bus operating cost,

firing corrupt employees, giving force retirement and controlling the labour unrest are the main, the source said. So far, 376 employees have been sacked following allegations of corruption and mismanagement and 1283 have been forced retired.

With a view to decreasing the operating expenditure, the number of manpower per bus has been reduced to 11.64 persons from 18.39 in five years ago. Now the total manpower of the corporation is 2025. Among them 1499 are labourers, 435 employees and 99 are officers.

If new buses and trucks are not added in its convey urgently, BRTC, the only public sector transport corporation, will go bankrupt soon, the source added.

SIA enters into computer software

Singapore Airlines Limited, Tata Consultancy Services (TCS), and Datamatics Limited have agreed to form a joint-venture company to develop and maintain computer software, says a press release.

The company will be based in India.

The decision was taken in Bombay last month following discussions among senior representatives of the three companies — SIA's Director of Management Services, Cheong Kai Mun, TCS's Deputy Chairman, F C Kohli and Datamatics Chairman, Dr L S Kanodia.

The joint-venture is expected to be incorporated in the first half of 1995 and will initially concentrate on meeting SIA's development requirement.

Home market of tea picks up

CHITTAGONG, Dec 12: Bangladesh tea's home market has picked up while its exports slid down.

As a result, according to market reports, internal sale in the auction markets here registered an increase by over two million kilograms, in 29 actions held during current year compared with the same number of auctions held in 1993.

Out of a total of 29 auctions of 1994, the tea purchased by local buyers for home markets rose to 12.85 million kilograms from 10 million kilograms purchased during the same number of auctions in the previous year, reports said.

The weekly tea sale in every season continues upto auction no. 45. This year the weekly auctions began from the end of April. Sources said the home market of tea had become strong following aggressive marketing tendency shown by the producers and traders in the backdrop shrinkage of export markets.

Bangladesh tea producers and traders, now battling for survival, seriously turned their

eyes to home markets by jumping into heavy media campaign from early period of last year.

According to official reports, during July to November 15 of the current fiscal year, the country exported 8.26 million kilograms of tea, down from 8.73 million exported during the corresponding period of previous fiscal.

Moreover, the average auction price of tea also slumped this year. Auction sources said, up to sale no. 29 this season, the average price recorded at Taka 41.82 per kg, down from Taka 49.84 per kg during the same number of auctions in the last season.

However, some of the tea companies launched the home marketing through colourful packet tea as a part of their diversified strategy to draw the attention of buyers, sources added.

CANBERRA, Dec 12: Trade Minister Bob McMullan will lead a large Australian business mission to India in mid-February, concentrating on five key industry groups, reports AP.

The Trade Department said it would provide "a unique opportunity to get to know key Indian decision makers and Indian business counterparts in mining, minerals and energy, food, agriculture and textiles, telecommunications, power and infrastructure, and services."

US upbeat after second free trade agreement in a month

MIAMI, Dec 12: The prospect of mammoth free trade zones in Asia and Latin America over the next generation has U.S. officials convinced that a new era of prosperity and opportunity is coming, reports AP.

That was the message delivered by officials at the conclusion of this weekend's 34-nation Summit of the Americas. It came less than a month after the 18-nation Asia Pacific Economic Cooperation group summit in Indonesia.

The first step in establishing a hemisphere-wide free trade system begins with negotiations that eventually permit Chile to become a partner with the United States, Mexico and Canada in the North American Free Trade Agreement.

The deadline for concluding negotiations for all participating countries is 2005. The target date for the Asia-Pacific free trade zone is 2020.

It was a weekend of soaring rhetoric and mind-numbing numbers. Clinton, mindful of frequent confrontations in the past with Latin America, said the current convergence of views constituted a "magic moment" that can usher in a "new era."

Warren Christopher, the normally restrained U.S. secretary of state, used words like "landmark," "renaissance," "extraordinary" and "unprecedented" to describe the proceedings.

Clinton spoke with relish about the prospect of a free trade area where, within a

decade, the hemisphere's 850 million consumers will be buying 13 trillion dollars worth of goods and services.

That compares with the 12 trillion dollars current gross national product of the Asia-Pacific free market in the making, an agreement Clinton and 17 colleagues from Asia nailed down last month in Indonesia.

After a 27-year hiatus between summits, the delegates assembled here agreed there was a lot of work to be done to strengthen ties. They vowed joint efforts on everything from catching criminals to making the hemisphere cleaner and greener.

The summit produced remarkably few mishaps.

Japan, US reach accord on flat glass trade

TOKYO, Dec 12: Japan and the United States have reached final agreement on increasing foreign access to Japan's lucrative flat glass market. Trade Minister Ryutaro Hashimoto announced Monday, reports AP.

The agreement came after nearly six weeks of fine-tuning a general accord announced October 1 on ways to boost foreign access to Japan's 4.5 billion dollars sheet glass market, the world's second-largest.

Hashimoto was speaking to reporters at a hastily arranged news conference. US Trade Representative Mickey Kantor was expected to make a similar

announcement Monday in Washington.

Details were not immediately announced.

The two sides had adjourned Friday after three days of glass talks in Washington, DC, saying that good progress had been made, although no agreement had been reached yet.

US trade officials contend that the three Japanese producers that dominate the market enforce exclusive sales contracts on most of the 400 domestic wholesalers.

American flat glass makers have market shares of more than 25 per cent in Europe and Latin America, but less than 1 per cent of the Japanese market.

The United States sought new talks on flat glass trade after a 1992 "action plan" on the issue failed to increase the American share of the market.

The current round of talks was extended after the two sides missed an October 31 deadline imposed by the United States to complete details of a new agreement.

On a separate issue, Vice Minister Hideaki Kumano told reporters earlier that no schedule has been set for the next round of stalled auto sector trade talks between the United States and Japan.

Ekran plans to borrow locally to fund \$6b dam project

KUALA LUMPUR, Dec 12: Listed property firm Ekran plans to borrow locally to fund a 15-billion-ringgit (six billion dollar) dam project which it is widely expected to clinch, company official said yesterday, reports AFP.

"There will be no foreign funds required for the project as there is enough money locally," said Ekran's Executive Chairman, Ting Pek Khing, after the company's Annual General Meeting and Extraordinary General Meeting here.

Ekran won a contract to do ground works on an environmentally controversial hydroelectric dam in Bakun, eastern Sarawak state, in January 1994.

But its proposal for the 2,400-megawatt power station which it submitted to the economic planning unit is still awaiting approval.

Ting, a close ally of Prime Minister Mahathir Mohamad, dismissed talk that listed tourism and timber concern granite, which he took over last month, would benefit from the Bakun deal.

"It is misleading to both Ekran and granite shareholders to say that granite may come to invest in the Bakun project," he said.

NCCB opens branch at Moulvibazar

A new branch of National Credit and Commerce Bank Limited has been opened at Moulvibazar, says a press release.

The branch was inaugurated at Yakub Mansion on Sylhet Road yesterday.

This brings the total number of branches so far opened to 23.

The Deputy Commissioner of Moulvibazar, Md Abu Syed, formally inaugurated the branch while the Managing Director (current charge), Mustafizur Rahman, presided over the function.

Azizur Rahman, MP, Mohammed Ali, Executive Vice President and Secretary of the bank and Syed Mohsin Ali, Chairman of local pourashava were also present.

Philippines prepares to host '96 APEC summit

MANILA, Dec 12: The Philippines is preparing to host the Asia-Pacific Economic Cooperation (APEC) summit in 1996 at the former US naval base in Subic Bay, the presidential palace said here Sunday, reports AFP.

An official statement said President Fidel Ramos had directed the Subic Bay Metropolitan Authority (SBMA) to speed up the construction of an international convention centre and two luxury hotels for the APEC delegates.

He also said all projects must be ready by early 1996.

The SBMA is tasked with converting Subic, once one of the largest US military installations overseas, into a free port and industrial zone. The complex is now one of the Philippines' main investment attractions.

The statement also quoted SBMA head Richard Gordon as saying the former naval airstrip in Subic, located 90 kms (56 miles) northwest of Manila, would be fully converted into an international airport by April 1995.

It is envisioned that the APEC delegates would fly directly into Subic which boasts modern infrastructure and would be far easier to secure than teaming Manila — from their

respective countries.

The palace gave no details on who would handle the development of the hotels and convention centre, or how much they would cost.

Ramos, who attended the first APEC summit at Seattle in 1993 and this year's meeting in Bogor, Indonesia, has said that Subic would showcase the country's efforts to attract international firms to the former US base.

The 1995 APEC summit is to be held in Osaka, Japan.

The 18-member APEC was established in 1989 as a forum for increasing trade and investment along the Pacific rim. Asia, North America and Latin America are represented in the body.

China's economy will grow steadily in '95

BEIJING, Dec 12: China's economy will grow steadily and inflation will drop from its current rate of over 20 per cent, an official report said Monday, reports AP.

"Inflation in 1995 is likely to decline notably from this year though it will still be double-digit," senior researcher Yang Qixian was quoted as saying by China Daily.
