Strong all-round demand led tea prices to remain firm to dearer at the week's auction sale held in Chittagong on

According to a Unity Brokers market report, the market opened at fully firm rates but continued to climb as the sale proceeded. By closing time the larger brokens gained by over Taka three per kilogram. The brokens rates are now above that of the corresponding fannings grade.

Tuesday last

The strength of the market is likely to continue during the coming auction sales, the market report said. The major buyers at the sale were Russia, Poland, Jordan, Sudan and Pakistan. Internal traders were also quite active.

Withdrawals at the sale were low and stood at 17 per cent of the offerings as against last week's 20 per cent. In the leaf category 22,290 packages were offered at the sale. Of which, the export buy-

In the dust category 4,449 packages were offered for sale at the auction, of which, the internal traders purchased 51 per cent while the export buyers brought 24 per cent and the rest remained unsold.

DUST: 4.449 packages were on offer and prices were about firm. Lower sorts occasionally inclined nominally.

The next weekly tea auction sale would be held in Chittagong on December 27 and would comprise about 23,000 packages of leaf and 3,500 packages of dust.

Massive gas reserves in northern Afghanistan await buyer

50,000 million cubic metres of natural gas reserves in nor thern Afghanistan are awaiting an international buyer, said an official in Mazar-i-Sharif yesterday, reports AFP.

"Potential buyers have shown interest, but they want to pay below the market price for our gas," said General Pyendah Mohammad, Deputy Director of the foreign relations department in Mazar-i-Sharif.

A representative of Junbish. or the National Islamic Movement headed by Uzbek General Abdul Rashid Dostam, Pyendah said although the export of gas reserves would solve financial problems in the northern provinces, this gas "was the property of all the people of Afghanistan."

Pyendah said he could not predict what the expected earnings from these massive reserves might be.

Pak rupee falls

KARACHI, Dec 21: The Pakistani rupee closed 0.01 rupee weaker at 31.88 rupees to the dollar in the kerb market as dollar supply dwindled due to a transport strike and worries about more violence in Karachi, dealers said, reports Reuter.

"Trading in the market was dull with low dollar supply because of fear of violence and a transport strike," dealer Owais Kalia of Khanani and Kalia International said.

Economists predict 9pc GDP growth in Malaysia

KUALA LUMPUR, Dec. 21: Malaysia's economy should grow by a robust 8.5 to nine per cent in 1995 with the government's hawkish stance on inflation damping possible overheating, analysts and economists sald, reports Reuter. -

If the forecast is realised, Malaysia would have notched eight consecutive years of more than 8.0 per cent gross domestic product (GDP) growth, the analysts said.

Their forecasts compare with the government's estimate of 8.4 per cent GDP growth in 1994 and 8.5 per cent in 1995.

Growth is expected to be broad-based with Malaysia's booming manufacturing sector once again leading the pack, followed by construction and services. "Manufacturing will remain

strong due to external demand and the effects of manufacturing activity relocating from Singapore," said Kevin Chew, economist at Baring Research (Malaysia) SDN BHD. Although no major surprises

are expected next year, possible blips could come from the inflation front, analysts said. The government announced

a mildly expansionary 1995 budget at the end of October, but inflationary effects of the budget are widely expected to be countered by the determination of Malaysian authorities tto keep prize pressures at bay in an election year, analysts

The government's five-year term ends in October but elections are widely expected to be held in the first half of next year.

"If you can have early elections, interest rates can rise progressively through the year," said Bruce Gale, analyst at Political and Economic Risk Consultancy Ltd (PERC).

On December 19, Malayan Banking BHD, the country's largest bank, reversed a twoyear trend by raising its base lending rate (BLR) by five basis points to 6.55 per cent.

The bank's move is a clear signal that Malaysian interest rates are heading higher next year, partly also in tandem with firmer global interest rates, analysts said.
