Prof Matin is also one of three former ministers under Ershad hamed as witnesses in the Special Case No 19 of 1993, better known as the Japanese Relief Boat Case.

Ershad and K Inoyama, a Japanese national, are the two accused in the case. The trial started without Inoyama, an employee of the Marubeni Corporation, who has been hiding.

Ershad is charged with abusing his official position in procuring the boats under a 2.5 billion Japanese yen grant, thereby causing the state to suffer financial loss to the tune of Taka 33 crore.

Prof Matin (PW-7) was the convenor of the cabinet subcommittee on purchase from 1986 till 13th August 1989. PW-7 testified that he was
