Japanese Boat Purchase Case Trial resumes Feb 12

Air Vice Marshal (Retd) Abdul Karim Khandkar, a former planning minister, yesterday appeared before a special judge's court trying deposed president Hussain Muhammad Ershad in a corruption case to testify as a prosecution wit ness, reports BSS.

A K Khandkar is one of three ministers named as wit nesses in Special Case No 19 of 1993, the trial of which be gan last year.

Ershad and a Japanese na tional are accused in this case better known as the Japanese Relief Boat Purchase Case.

Three prosecution witnesses made their depositions yesterday in the court of Zinat Ara. Additional and Sessions Judge (First Court), Dhaka and Special Judge. Former cabinet secretary A H F K Sadek and Deputy Commissioner Rajshahi M A Malek were the other witnesses besides Khandkar.

PW-10 Khandkar, who served as planning minister from August 1986 to March 1990, authenticated the proceedings of the council committee on government purchase dated 11th November 1989 which dwelt with the procurement of the boats.

PW-10, who was the con venor of the council commit tee in late 1989, identified his own signature, earlier marked as an exhibit by the court.

Khandkar, who read out the resolutions of the council committee dated 11-11-89 as asked by public prosecutor Abdur Razzak Khan, said the meeting was briefed about the purchase of boat under a Japanese debt relief grant and advised the Relief Ministry to execute the directives of the President on the subject.

The case relates to accept ing the second lowest bidder Marubeni Corporation — in procuring boats under a 2.5 billion yen grant in 1989 at the directives of Ershad, ignoring the offer of Kingshu Mataichi. another Japanese firm.

The country suffered a loss to the tune of Taka 33 crore because of Ershad's directives to procure the boats from Marubeni Corporation, the charge said.

Prof M A Matin, a deputy prime minister under Ershad testified in the case on January

During cross-examination. Khandkar said he has not come across any file which dwelt on the background of the purchase of the boats. He affirmed that the evaluation committee formed by the gov ernment had observed that the quotation submitted by Marubeni Corporation was ac ceptable from the technical point.

He also stated to have seen the report of the Bangladesh ambassador to Tokyo in which the envoy observed that since Kingshu Mataichi has no boat building facility, all boats. should be procured from Marubeni.

A H F K Sadek, who was Principal Secretary of the President's Secretariat under Ershad, deposed that he had seen the brief sent to the pres-

PW-11 M A Malek, who was a director in the President's Secretariat and later at the Prime Minister's secretariat from January 1987 to June 1992, in his deposition said he was a witness to the seizure of documents from the Prime Minister's secretariat on 4.1.1992 by the investigating officer of the case. PW-11 authenticated his signature and that of Faziur Rahman.

The trial was adjourned til February 12.

A K Khandkar who saw Ershad after nearly five years shook hands with the deposed general, sitting the dock, be fore leaving the court after making his deposition.

"It is only the present government which is trying to snatch the rights of the private sector labourers," he re-

Referring to the trade unions' demand for a halt to the government's privatisation move, he claimed the unions were not opposed to privatization as such. But, he added the industrial units already disinvested had faced closure due to the authorities' wrong policy. to work out the formalities. The two sides agreed on the need for frequent exchanges of visits at all levels to provide greater momentum to bilateral cooperation in areas of mutual interest, it said.

In view of the liberalisation of economies in the two countries, the two leaders agreed on the desirability of coopera tion between their respective private sectors and of advanc ing this process by all possible means including the estab lishment of joint ventures.

They also agreed to take necessary measures for effec tive implementation of the decisions of the Bangladesh-Sri Lanka Joint Economic Commission which is scheduled to meet in the first half of this

The two sides, according to the communique, expressed the hope that the existing cultural cooperation between the two friendly countries. linked by their common cultural her itage, would be further stren gthened.

They welcomed the signing of the Annual Executive Programme for cultural cooperation between the two countries for the year 1995, 1996 and 1997. They also decided to encourage the exchange of cultural troupes between the two countries.

The two leaders reviewed the progress made by SAARC following the Seventh Summit in Dhaka. They noted with sat islaction the progress made under the Integrated Programme of Action as well as the establishment of the SAARC Drug Offences Monitoring Desk in Sri, Lanka and the SAARC Meteopological Research Centre in Bangladesh.

They also noted with satis faction that due emphasis had been given to the core areas of poverty alleviation and trade liberalisation and agreed that other related economic issues should not be addressed.

Exchanging views on trade liberalisation in the region, the Bangladesh Prime Minister and SAARC Chairperson has agreed with the view of the Sri Lankan side that the first round of negotiations under the SAARC Preferential Tra-

ding Arrangements (SAPTA should be expedited.

The two leaders hoped that all formalities such as negotiations on tariff concessions would be completed in time to operationalise SAPTA on schedule.

They also held discussion on cooperative arrangements already established between SAARC and other regional and international organisations and agreed on the need for further expansion of such cooperation.

Focusing on international situation, the two sides expressed satisfaction at the encouraging developments in the Middle East with the signing of the peace agreements be tween the PLO and Israel and between Jordan and Israel and hoped that it would enable the Palestinians to achieve their inalienable right to a homeland and help reach a comprehensive settlement of the problem.

Expressing deep concern at the deteriorating tragic situa tion in Bosnia-Herzegovina, the two sides stressed the need for a negotiated settlement of the problem under the UN of

Reviewing the current global economic situation, the two sides noted with concern that ever widening gap be tween the rich North and the poor South remained the ma jor challenges facing the international community."

They also expressed con cern at the dangers of the degradation of the global environment and underlined the need for greater international cooperation to address the root causes of the problems.

"But to take a stranger (in the cabinet headed by the President) is not permissible under the Constitution. And even to amend the Constitution the Parliament members who resigned have to be recalled and a referendum also has to be held."

"If they (Opposition) agree to allow the members of Parliament to become ministers in the national government then the problem is solved." Rahman asserted.

The logic of the demand to dissolve Parliament after the 147 Opposition MPs resigned err masse was also questioned by the Finance Minister. "If 100 or so Parliament members resign and that is taken as a reason for the dissolution of Parliament then multi-party democracy cannot work." he reasoned. It is an expression of a

'negative' no-confidence motion against the government after the Opposition earlier failed to muster enough support for a 'positive' no-confidence motion, he said, "What is happening today can also happen tomorrow."

But he concluded by sounding hopeful about a solution to the current political impasse. "But we should not give up hope, we should try to resolve the problem," Rahman said with guarded optimism. "I am trying to persuade my (cabinet) colleagues to go to the maximum extent to resolved this tension-ridden situation."
