The Petrobangla in a letter related to a news item of The Daily Star on "Oil exploration in the Bay. Seismic survey data sent to Singapore for study" published on March 31 last said that a part of the story was

incorrect. It said that there was no provision in the production sharing contract (PSC) for block 15 that would allow the companies to set up a 40 megawatt power station in the Chittagong Hill Tracts using natural gas from the Semutang Gas Field.

The Daily Star report had said. "The agreement (on the PSC for block 15) between the Dutch-Scottish consortium and the government would allow the companies to set up a 40 megawatt power station in the Chittagong Hill Tracts using natural gas from the Semutang Gas Field."

They Daily Star report did not mention that the PSC had a provision for the power station. Unless the agreement is signed, the 40 MW plant as proposed separately to the Energy Ministry in December last year by the Holland Sea Search, Cairn Pic and Midland Electricity can not be materialised due to the rules for the block negotiations,


