Needleart — one of the typicalities of Bangladeshi embroidery — is a unique art form that combines the finest techniques of needlecrafting and art.

A piece of silk, strengthened by two layers of cotton, is the canvas on which images depicting the emotions of life and nature in exuberant colours are created through millions of ultra-fine handstitches. Each square inch of needleart work may contain upto a thousand hand stitches!

Seminar on CHT in city

Recognise minorities' culture

Discussions at a seminar on 'Chittagong Hill Tracts: Problem and Solution' held in the city yesterday called for dissolving the 'cluster villages' and settling the repatriated refugees in their own lands.

Convenor of the committee, Lutfar Rahman Shahjahan was in the chair during the morning session which was addressed, among others, by Rashed Khan Menon MP, Salauddin Mamid of Ganoforum, Hasan Imam of Nirmul Committee, Deputy Attorney General AF Hasan Arif and Sharadindu Shekhar Chakma of Liaison Committee, Parbatya Chattagram.

The National Committee for the Protection of Fundamental Rights in Chittagong Hill Tracts organised the seminar in which all the sessions were followed by open discussion on the pros and cons of the problems and their solutions.

The speakers, comprising members of Parliament, politicians, cultural activists, lawyers, literateurs, NGO and tribal representatives, called for dissolving the 'cluster villages' and settling the repatriated refugees in their own lands.

Land related issues were discussed by Rashed Khan Menon, Kabita Chakma, Adilur Rahman Khan, while the issue of repatriation of refugees were discussed by Dr Arbar Choudhury and Salim Samad.

Furthermore, the speakers stressed the need for continuing the ceasefire and peace talks for reaching a solution to the problem. In this regard, they called for holding the talks in Dhaka with the participation of all political parties for a national consensus.
