The impetus for the most recent dispute is a request made by American cargo carrier Federal Express Corp. to add the Philippine city of Cebu to the Asian destinations it serves from Japan. United Airlines also wants to serve Kuala Lumpur, Malaysia, from the newly opened Kansai International Airport near Osaka, central Japan.

Cebu is among 11 Federal Express requests for new routes controlled by Japan, which Tokyo is refusing to grant in an effort to force the United States to change the treaty.

The 1952 US-Japan aviation treaty grants both countries rights to fly beyond destinations in each other's countries to third-country destinations so-called "beyond rights."

But Japan says it is being shortchanged.' Under the

treaty, which mentions specific airlines by name. Northwest Airlines, United Airlines and Federal Express can increase their flights to Osaka, Tokyo and Naha, Okinawa and

They were fugitives for 13 months before being arrested two weeks ago in Miami. They had been living in a luxury oceanside apartment about 25 kilometers (15 miles) north of the city.

Before their flight, the Schneiders lived elegantly in a restored castle outside Frankfurt and rode in a limousine.

Schneider is accused of buying some of Germany's oldest and most prestigious real estate by overvaluing property and using front companies. When he and his wife fled, they left behind 3.6 billion dollars in debts.

FICCI chief suggests continuation of tax-holiday up to the year 2000 Mahbub Jamil, President of

the Foreign Investors Chamber of Commerce and Industry (FICCI), has suggested the continuation of tax-holiday facility up to the year 2000. He also suggested reduction of Corporate Income Tax in the next budget.

In an interview with The Daily Star, he said the continuation of tax-holiday would attract more investment both local and foreign.

He was interviewed by Parveen Ahmed and Raffiq Hasan.

The full text of his interview is given below:

The Daily Star (DS): What is your sector's expectation from the next budget? Do you think the priorities in the last budget were implemented prop-

Mahbub Jamil (MJ): The budget must help create a congenial environment for large scale private investment. both local and foreign. We feel very strongly that a reduced Corporate Income Tax together with continuation of 'tax holiday' facility at least up to the year 2000 would be good incentives for attracting both local and foreign invest-

DS: Do trends in your sector show a growth or decline? Whij?

MJ: Yes, it is growing, but at a very slow pace. Major reasons for such a slow pace of growth are - policy inconsistencies. frequent changes in various policies of the government, gaps between policies, non-

transparency of a number of policies, infrastructural bottlenecks like -inadequate power supply, non-availability of telecommunication facilities and lack of proper road communication.

DS: What kind of problems did your sector face with the fiscal policies adopted in the last budget like VAT, tax structure and tariff duties?

MJ: The major problems are: high rate of Corporate In-

come Tax, tariff anomalies. fixation of high tariff values for goods and materials of European/Western origins, requirement of multiple VAT registration for different units of a single entity and levying of electricity duty to Tk 0.15 on each unit of self-generated electricity by industrial com-

DS: What are your views on the on-going economic reforms and what particular impact did it have on your sec-

BUDGET '95-96: Business leaders speak out

MJ: We feel the on-going economic reforms are very positive and some are even much better than many other countries of the South Asian region. But the implementation of the reform programmes is not up to expectation. If all the reform programmes are truly implemented, we are sure that there will be a surge of foreign private investment. We have no hesitation in saying that despite all the shortcomings in the implementation of various reforms, our members have benefitted immensely and

This chamber strongly feels that immediate steps should be taken for proper execution and implementation of various policy reforms so far undertaken by the government.

DS: How do you look at the over-all economic scenario of the country and what are your suggestions to improve it? MJ: We are not pessimistic about the prevailing economic scenario. It is definitely better than the past decades. But it needs further improvement at a faster pace as Bangladesh has to compete with the neighbouring and other developing

countries. DS: How many members are there in your chamber? When

was it formed? MJ: The Foreign Investors Chamber of Commerce and Industry has 63 members consisting of multinationals, hundred per cent foreign and joint-venture companies. It was formed in 1963.

DS: What was the estimated annual turnover of your sector last fiscal year and how much is it-likely to be in 1995-96? What was the estimated contribution of your sector to the national exchequer in the form of taxes and duties?

MJ: The annual turnover of FICCI members is around Tk 20 billion. Our members contribution to the national exchequer in the form of taxes and duties is around 60 per cent of the total private sector contribution.

UN appeals for more money

GENEVA, June 3: The United Nations said Friday it needed an additional 261 million dollars for aid operations in former Yugoslavia for the next six months, reports AP.

"The reality of today is that more than two million people need humanitarian help and will continue to need it for the foreseeable future," said UN High Commissioner for Refugees, Sadako Ogata.

"Each day brings news of renewed tensions, ethnic cleansing and fighting in Bosnia and Herzegovina and Croatia," Ogata said in a statement.

The UN aid budget for the whole year is 470 million dol-

UNHCR, the main aid agency in former Yugoslavia, is doing well as far as funding is concerned. It said it needs an additional 44 million dollars for the rest of the year.

However other organizations, like the World Food Programme, face severe shortfalls. The United Nations is help-

EU still deadlocked over aid for ACP states

BRUSSELS. June 3: The European Union is still deadlocked over the amount of aid it will offer African, Caribbean and Pacific (ACP) countries over the next five years, European Commission officials said yesterday, reports Reuter.

The 15 EU member states are sharply divided over how much to offer the 70 ACP countries through the European Development fund with the European Commission and France leading demands for an increase and Britain and Germany the most firmly against.

"It's completely blocked." an official said, noting that development ministers did not even discuss the issue when they met in Luxembourg on

BUCHAREST, Romania June 3: Tens of thousands of energy workers and coal miners went on strike Friday to protest low wages — one in a series of labour disputes in Romania's painful transition to a market economy, reports AP.

Talks designed to avert the strike between the government and union representatives broke down Thursday.

There were no immediate effects for the population of 23 million as workers from the night shift worked overtime. but union leaders warned of national power outrage if workers stayed away.

"The national energy grid could fall in a matter of hours. said Vasile Suta, head of energy workers union by telephone.

He said three workers from the night shift who had continued working had been hospitalized, suffering from exhaustion.

The government said it, would call in former employees in the power industry to ensure energy supply, and the state news agency Rompres said that in western Romania the army was on stand-by to

By law, energy workers are not allowed to leave the workplace until the next shift has replaced them.
