Giants' Fed Cup clash today



The Met office forecast a sunny afternoon but the football buffs in the country will be taken by

the storm of a match when the two most crowd-pulling outfits - Mohammedan Sporting Club and Abahani Krira Chakra face each other in the final of the Beximco 13th Federation Cup football tournament at the Dhaka Stadium today.

The Dhaka derby kicks-off at 5.30 pm. Bangladesh Television and Radio Bangladesh will cover the match live from the venue.

Meanwhile, both sides are all set for their seventh final engagement in the meet with Mohammedans looking for their second successive title this year.

The black and whites, who had a disappointing season last year failing to win a single title, this time have produced the most balanced outfit and deservingly won the DMFA Cup, the season's curtain-raiser meet.

Their nine wins from nine matches this season including a 1.0 win over Abahani a reveals that without a doubt they are the most consistent team at the moment.

"We are the most consistent outfit. So our boys deserve to win the final" said an optimistic Badal Roy, the manager of Mohammedan Sporting Club, during a light practice session at a city ground last afternoon.

Badal Roy, who was also in charge last year, disclosed that all the players except Ranjan and Milon were fit and raring to go.

Ranjan is nursing a calfmuscle injury but is confident of baking his place in the final eleven while striker Milon, who twisted his left arm in Mohammedans semi-final engagements against Brothers Union, will be replaced by Lodhi Baba Lola, one of the two Nigerian recruits of Mohammedans.

Abu Yousuf, a former national defender and the chief coach of Mohammedans, while elaborating about the

'clash of the titans' explained that his team will rely on Arman, their midfield powerhouse.

Yousuf, who retired as a player last year, termed Arman as a potential matchwinner. "He has the quality of keeping his cool in a nervewrecking situation and possesses the necessary firepower to turn the table at any moment."

"But my motto is not to play for a win only", said Yousuf and added that his boys will have a positive approach in the match.

On the other hand, Abahani will be looking for maiden title this season after failing to retain the DMFA

The new-look Abahani with at least eight youngsters in their ranks, will, however, bank on their two foreign recruits — Vladimir and Sergei.

"The two booters are very good players," said Mohammedan coach Abu Yousut.

However, his Russian counterpart Boghdanov spoke little about the match but summed up with a very significant remark Both are equally balanced and the chance is fifty fifty.

Because one can never predict the outcome of a match when the two giants of the country clash to uphold their prestige.

Meanwhile, the organisers Bangladesh Football Federation (BFF) have made all necessary preparations for a smooth holding of the final.

Rate of tickets for the gallery has been fixed at Taka 30 while for the VIP enclosure it will be Taka 50 each. The tickets will be on sale from 2.30 pm and the gates will also open simultaneously.

Best woos Ince to stay

MANCHESTER, June 20: Manchester United legend George Best called on Paul Ince to reject Inter Milan and stay at Old Trafford on Monday, reports AFP.

England midfielder Ince is considering a seven millionpound (11 million-dollar) move to Inter Milan after United gave the Italians permission to talks to the player.

Ince, who is said to have been stunned by the club's decision to let him go, is believed to have been offered a contract of around 25,000 pounds a week and flew to Milan last week with his wife to discuss terms.

But best, who played for United in the late 1960s and early 1970s, insisted: "I would stay. Look at the British players who have gone over there - very few have come out smelling of roses.

Top guns in topsyturyy



LONDON, June 20: World number one Andre Agassi will play a

qualifier to open his bid for a second Wimbledon singles title on Monday but could run into trouble in round three, rein round four. ports Reuter.

1992 champion who suffered a hip injury during the French Open, could face a testing third round match against a tall and dangerous compatriot, world number 25 David Wheaton, a Wimbledon semifinalist four years ago.

And if he survives that, he should come up against Ukrainian 15th seed Andrei Medvedev in the fourth round before a quarter-final against the survivor of a section that includes seventh-seeded Wayne Ferreira of South Africa and German ex-champion Michael Stich, seeded ninth.

Third-seeded Boris Becker of Germany could face a fourth-round battle against Swede Stefan Edberg, now the 13th seed after a disappointing

The two have won five Wimbledon singles titles between them, Becker winning three. They met in three successive finals from 1988 to 1990, the Swede winning two of them.

With Becker drawn to face Agassi in the last four, should they both get that far, the potential repeat of last year's final between holder Pete Sampras and Croatian Goran Ivanisevic would take place this time in the semifinals, they are seeded second and fourth respectively.

Becker's opening clash is against 1994 French finalist Alberto Berasategui of Spain, unseeded because he has no known torm on grass.

Then he should face Swede Jan Apell better known as a doubles exponent. Edberg, who seems to have

been on a downward spiral this year, could find himself under pressure in a secondround clash against 1987 champion Pat Cash of Aus-

Ivanisevic should progress smoothly through the early rounds but his first encounter with a seed is against the towering American Tood Martin

Martin, the 14th seed, has The Flashy American, the not shown the form lately that brought him the 1994 Queen's Club title and a semifinal place at Wimbledon. But he insisted last week he is getting close and if he finds it in time, Ivanisevic could face a premature exit.

The survivor of the section has a potential quarter-final against Yevgeny Kateinikov of Russia, the sixth seed but not a noted grass-court player.

Sampras, chasing a third successive title, begins his quest against Karsten Braasch, a German ranked 119th in the world, and should progress smoothly to the last 16. There he could face Fren-

chman Guy Forget, whom he beat on Sunday to win the Queen's Club title. Forget has reached the quarter-finals in his last three Wimbledon appearances over the past four years.

The other seeds in Sampras' quarter of the draw are Spain's 1993 and 1994 French Open champion Sergi Bruguera, at number eight, and Olympic champion March Rosset of Switzerland, who is
