Join the Joyride

Thousands of students crowd the campus ' of Dhaka University every day and many of them come from far-off places like Gazipur. Uttara, Narayanganj etc. So, for these nonresidential students it would be extremely difficult to make the journey to and from their homes each day were it not for the DU buses for students. These faded red buses present familiar sights on the campus everyday and can be seen going on their selected routes at different times during the daytime. It is quite an amazing sight to see these huge buses jam-packed with young people, many hanging from the doorways and some even sitting on the windows!

The buses have beautiful names like Baishakhi, Chaitali, Moitri, Khonika, Srabon, Ananda, Taranga, Kinchit, Hemanta and Ullash. Each has its own separate route, and the best part is that the fare is always Tk one for any distance! The different routes cover almost all parts of the city from Narayanganj to Jatrabari, from Motijheel to Mohammadpur, from Farmgate to Tongi and Gazipur etc. The buses start on their respective journeys about 7 am to pick up the students from various stops. There is a bus almost every hour, the last bus reaching the campus around 10:30 am. The return journey starts from about 12 pm. The timings are scheduled to allow the students to come and go according to their class routine.

Some people seem to think that it is unsafe to travel in these buses with so many boys and girls packed together like sardines. In reality this is not so. The first four seats in every row are for the female students, so the

front of the bus is packed with girls and the back with boys. The drivers and conductors affectionately addressed as 'Mamus' are always helpful towards the girls. However, some of the buses, especially Khonika, are so crowded that if one wants to grab a seat (of which there are too few), one has to arrive at least 45 minutes ahead of time. The main bus-stand is the Registrar Building but students are also picked up from DUS, the road opposite the university mosque, and Curzon Hall. But sadly, compared to the number of students travelling in them, the number of buses are too few. Some of the buses are packed to double their capacity and still the 'mamus' keep pushing more students in. What an experience it is to travel like this when there is no room for even standing up properly and almost no breathing space! In fact once this was so bad that a girl fainted from the heat and stuffiness. This leaves some of the students no choice but to go hanging from the doorways, and this is extremely dangerous for a serious accident could occur at any time. So, for the safety of the students if not for their comfort, the university authorities should think of more such buses.

Nevertheless, these buses serve their purpose and for most student have become an integral part of their university lives. In their own way, they form part of the toughening up' process which a student should go through to become ready for the manifold challenges lying ahead. So, hop aboard for the ride, while you can.


