# Judgement on prayer for quashment Aug 1

The High Court judgement on the prayer for quashment of the criminal case against Taslima Nasreen is scheduled to be delivered on August 1.

pending before the Chief Metropolitan Magistrate's Court, Dhaka.

The Division Bench comprising Justice Md Mozammel Huq and Justice Md Nurul Islam fixed the date for the judgement, following conclusion of the hearing vesterday.

Barrister Amirul Islam. counselor for the petitioner. submitted that the alleged offence was committed in India, outside the periphery of the country, but in this regard sanction under Section 188 of the Code of Criminal Procedure was not obtained an absconding person. properly.

He also argued that though the case was filed under Section 295 (A) of the Penal Code, the informant did not obtain sanction of the government as required under Section 196 of the Code of Criminal Procedure.

He also argued that the Ministry of Law and Justice was the proper authority to give such sanction, but in this case the sanction was accorded by the Ministry of The criminal case is now Home Affairs. The proceedings, therefore, should be quashed, he argued.

Assistant Attorney General Syed Abu Kawsar, on behalf of the government, submitted that as the accused was a fugitive, no petition on behalf of her could be entertained He also argued that there were some problems in get ting the sanctions, but it could be modified later.

In reply to the submission of the prosecution, Barrister Islam further argued that as the petitioner went abroad with valid passport and visa she was neither a fugitive nor

tenced and convicted him to suffer imprisonment for life.

This is the first case of its nature under Section 561 (a) of the Code of Criminal Procedure (CrPC) wherein the High Court division in exercising its inherent power had set aside a conviction and quashed the proceeding of the trial court.

Because of time bar the accused person failed to appeal against the verdict of the lower court and advocate Mahbubur Rahman and Advocate Farah Mahbub appeared in the High Court for the accused for converting the appeal into criminal miscellaneous case under Section 561-a of the CrPC with amendments of memo of appeal to prevent the abuse of the process of court.

The appeal was made to secure the ends of justice as there was no forum or remedy available to redress the grievance of the aggrieved person, the accused's lawyers

The judges after hearing the submissions of both

During the final hearing of the matter invoking the inherent powers of the High Court Division, the judges accepted the contention of advocate Mahbubur Rahman.

The lawyer contended that the case was one of no evidence or insufficient evidence to warrant the punishment awarded to suffer imprisonment for life. He further submitted that the conviction was not based on sufficient evidence to sustain the same and there were gross irregularities which is tantamount to committing illegalities. As such, he contended the trial court erred law and acted without jurisdiction and hence the conviction and sentence is liable to be set aside and

The High Court accepted the argument and passed the order setting aside the verdict of the lower court and quashed the conviction and sentence of life imprisonment of Sohail Ahmed

Shadhina told the press. there are 18 underaged girls in Shilpi's quarters. Two of them - Lipi and Josna wanted to come out with Shadhina, but Shilpi mercilessly beat them into staying

We would like to seriously raise questions about police conduct in this matter. While praising them for rescuing Shadhina, we are stupefied by the way they behaved about the other girls. Why were Josna and Lipi not also rescued? Why no investigation was carried out about other underaged girls, once Shadhina made it known.

In fact there appears to be an inexplicable ( or may be it is not that inexplicable) reluctance on the part of the Narayanganj police to go after Shilpi. According to press reports, on being questioned as to why Shilpi and her associates were not being arrested, local police officer-incharge said "they are hiding". When newsmen, after making their own investigation, told the police that Shilpi, who happens to be pregnant, was very much in her house, the OC allegedly said "a pregnant woman cannot be arrested."

We appeal to the highest authority of the police, that the 18 girls ( who may have already been dispatched somewhere else) mentioned by Shadhina in her press statement, be rescued immediately. Special search be made for Josna and Lipi. Investigation be launched against the police officers who did not take action to release the other under-aged girls in Shilpi's captivity. while they were rescuing Shadhina.

We appeal to all the women's organisations to help give a new turn to Shadhina's life. The legal bodies that look after women's rights should immediately do whatever they can to release Josna and Lipi and the other 18 girls in Shilpi's clutch.

Let us also think what we can do about the thousands of 'Shadhinas' (imagine, just 14 year old, and many are far younger), who continue to lead the life from which Shadhina has been rescued.

From this story, and many

others published at different times, it appears that young girls are usually picked up from such places as bus and launch terminals, and from railway stations. Can we not place social workers at these places, or special squads of women police to protect such young girls? Big sign boards, warning young women from falling in the hands of such touts, should be put up in these places. Meetings should be organised by social welfare department and by private women's groups, in all places where women work, warning young girls about accepting offers from strangers, and how to deal with such situations.

NGOs working in the urban areas must develop programmes to educate young factory workers to protect themselves in such situations.

Finally a special department should be created within the police force, to deal with the rising child prostitution problem in Bangladesh. This could, but not necessarily, be staffed by the women police force. Social welfare Department and NGOs should be brought together with this special department, and all made to work together to address this


We appeal for urgent police and government action in this regard. Remember, for every moment of delay, a minor girl's life is being put to risk of being crushed under the hideous lust of sexual

SATKHIRA, July 26: One person was killed and at least eight others were injured in a clash between the people of two villages at Jhaudanga bazar under Sadar thana here today.

The dead was identified as Golam Sarwar, 30, of Gobindakathi village. He received bullet injuries in his abdomen and died while being taken to the Satkhira

Police arrested eight persons in this connection and recovered a gun and 38 rounds of bullets from the spot.

Police said the clash erupted at Jhaudanga bazar when the office-bearers of a local club asked one of its members to pay Tk 100, the price of a club lottery ticket he had purchased on credit.

The residents of Gobindakathi and Patharghata villages, equipped with sticks and other weapons, joined the clash between the two groups of the Jagoroni Club members.

The Bangladesh Environmental Lawvers Association (BELA) has served a legal notice upon authorities concerned with appeal for appropriate measures about the pollution of Dhanmondi Lake, reports UNB. The BELA served the no-

tice Tuesday on the Mayor of Dhaka. Secretaries of the ministries of LGRD and Cooperatives. Public Works, and Fisheries and Livestock, Chief Engineer of Public Works Department. Director General of the Department of Fisheries. WASA Chairman, Director General of the Department of Environment (DOE) and Organising Secretary. Bangladesh Shaukhin Matsya-Shikari Samity, says a press release.

The notice said lack of concern and negligence of the authorities responsible for maintaining the lake had created an undesirable situation in the surrounding area. The water of the northern part of the lake turned thick and black spreading unbearable stench. According to the press

release, the residents of Dhanmondi area requested the BELA for legal measures with regard to certain actions and inactions of the authorities allegedly contributing to

The level of recent pollution reached such a stage that the entire fish lot of the northern part of the lake floated upwards, either dead or struggling for survival.

#### Arrest warrants for Karadzic, Serb army chief

THE HAGUE. July 26: court investigating was crimes in the ex-Yugoslavia Tuesday issued arrest war rants for Bosnian Serb leader Radovan Karadzic and his military chief Ratko Mladic after charging them with genocide, reports AFP.

In a development that will seriously complicate the work of international mediators the international criminal tribunal for the former Yugoslavia sent warrants for their arrest to the Bosnian stronghold of Pale, Sarajevo and Belgrade.

Court prosecutor Richard Goldstone said in his indict ment that Radovan Karadzic and Ratko Mladic committed genocide, from April 1992 in the territory of the republic of Bosnia and Herzegovina by their acts and omissions.

The Serb leaders commit ted a crime against humanity in concert with others by persecution Bosnian Muslim and Bosnian Croat civilians on national, political and religious grounds." Karadzic and Mladic head

a list of 24 Serb officials which includes a leader of Serb separatists in Croatia Milan Martic accused of responsibility for a reprisal shelling of Zagreb on May 2.
