
# 70 pc areas in Sherpur flooded Heavy downpour, erosion further aggravate situation

SHERPUR, Aug 22: The third spell of flood hit the district which started from last week with the onrush of hilly waters across from Indian border, sharply rising water level in all the rivers under the district.

In the period the water level of Brahmaputra already crossed the danger level Friday. The river Brahmaputra is flowing 18 cm above the danger level at Sherpur-Jamalpur ferry ghat point and the road communication between Sherpur to Dhaka via Jamalpur-Tangail has been disrupted in the two consecutive days. It is mentionable here that the incessant rainfall over six to eight consecutive days has paralysed normal life in the district.

Forty-five unions out of fifty-one in five thanas of the district were badly affected by the third spell of flood. About 70 per cent areas of the district went under wa-

The administration is yet to estimated the losses finally due to flood.

According to local sources, the third spell flood already destroyed recently transplanted Aman paddy on over seventy thousand acres of land. Many new point of the flood protection embankment have been damaged. About five kilometre flood protection embankment in various places of the district were badly damaged. Many dwellings damaged due to second spell flood and those were re-constructed. The third spell of flood again damaged such types of dwellings.

On the other hand, erosion has taken a serious turn in same river adjoining areas of the district.

At least one lakh people have been marooned in different thanas of the district. No rescue operation as yet have started to evacuate the uninterrupted flood, erosion victims, only some voluntary groups are operating. The worst affected areas are. Kamarerchar union, Charpakkhimari union, Dhala union, Kamaria union, Boulayerchar union, Charmuchariya union, Charsherpur union. Bajitkhtla union and Rouhabetmaryy union of sadar Sherpur thana. Gagra union. Hatibandha union, Hashlibatiya union, Ranygamati union, Kanasha Dynshil union of Jhenaigati thana, Nayabel union. Bagbere union. Kaloshpara union. Zugania union. Raznagore union and Marichpuran union of Nalifabari thana, Kurikahaniya union. Khoirakazir Char union and Beluya union of Srebordi thana, five unions of Nakla

At least five lakh people out of twelve lakh people of the district are passing their

days in misery. Meanwhile, the river Brahmaputra while eroding the bank of eastern side has also devoured vast tract of land including the approach road towards Sherpur-Jamalpur ferry ghat compelling Roads and Highways Department to construct alternative road to maintain

communication from Sherpur to Dhaka via Jamalpur. In total erosion of river Brahmaputra and Bhugai have rendered over 20 thousand people homeless in two thanas of the district during last 15 years.

Our Correspondent from Pabna adds: Flood, with all its fury, came for the third time within a short span of seven weeks in Pabna next to river Jamuna and Padma. which caused havoc to about four lakh people of eight, out of nine thanas of the district.

At least 50,000 men women and children were lying marooned in Bera, Sujanagar, Faridpur and Bhangora thanás while vast tracts of land in Pabna sadar, Santhia, Ishurdi and Chatmohar

Over 175 educational institutions, 8 hats and bazars, nearly 80,000 acres of crop land, miles and miles of village roads, hospitals, rural post offices, union parishad offices became submerged.

Over one lakh people belonging to eight flood-affected thanas, namely, Bera, Sujanagar, Faridpur, Santhia, Bhangora, Chatmohar, Ishurdi and Pabna sadar, specially from the char areas. were compelled to take shelter on flood control embankments, nearby high lands, schools or colleges and in union parishad offices or fields. They are mostly living under open sky and were helplessly braving torrential rains and scorching surveys and other adverse situations. They need food, shelter, clothings, drinking water, medicines

Recurrence of flood for third time brought untold miseries even to those not directly affected by flood Commodity prices have gone up abnormally -supply of essential commodities, vegetables, fish, eggs, milk etc. were scarce as widespread

Our Correspondent from Jamalpur in the meantime adds: Flood for the second time in less than 30 days has further worsened the situation in the district owing to continuous downpour and on rush of hilly waters from across the Indian region following rise in the water level in the rivers of Jamuna, Brahmaputra and its tributaries. In the district fresh areas went under water, according to official and unofficial report received till Sunday.

The river Jamuna flowing 48 cm above danger mark at Bahadurabad ghat and Brahmaputra flowing 28 cm above its danger market Dewanganj point Sunday evening, according to the district WDB sources.

The flood situation in the low-lying areas of the district and its surrounding areas remained unchanged.

The total number of flood affected unions stands at 45 out of 68 in seven thanas and some areas of Jamalpur pourashava were also submerged.

According to district administration sources, about 50,000 people belonging to 6,000 families of the district have been affected. Over 8000 houses have been totally damaged and 8,000 houses were partially damaged by the flood.

A total of 16 km pucca roads and 6,000 miles of rural kutcha road have gone under flood water. Seven bridges, 17 culverts were totally damaged.

Official sources said about 2.5 lakh acres of land of newly planted aman crops had gone under two to 10 feet deep flood water. The planted aman paddy are totally or partially damaged. District fisheries department sources said about 10 hectares and about 100 fish beds worth about Taka 1.50 crore were washed away by the flood waters.

About 150,000 people have been marooned. One hundred educational institutions were closed.

The government has sanctioned Taka 50,000 in cash, 50 metric tons of wheat as relief for the flood victims in the district.

The Daily Star correspondent, while visiting the affected areas in five thanas of the district gathered that road link between district town and other thanas headquarters were suspended due to inundation of flood water on the road.

SIRAJGANJ, Aug 22: District Anti-Corruption Bureau (DACB) filed two cheating cases against six people with Belkuchi and Shahjadpur thanas, according to official sources, reports UNB.

#### Coaster, microbus passengers robbed

The armed tribal terrorists, stopped a passengercarrying coaster a micro-bus and a motor-like at Bhairaba on Khagrachhari-Dighinala road. They robbed cash from the passengers at gun-point The vehicles were scheduled for Dighinala from Khagra chhari.

Creating panic among the passengers, the armed terrorists numbering about 8 to 10 wearing 'black musks' committed robbery and left for nearby forest, the eyewitnesses said.



mainly capsized due to the negligence of the driver who was driving the launch as he was not well-trained. Further the passengers became worried when the engine of the launch stopped near Raghunathpur. Almost all the passengers boarded on the roof top as a result the launch lost its balance and at last was caught in a whirlpool in about 35 feet deep water of river Chitra, said Muktadir Mia, 70, of village Raghunathpur who was an eyewitness. Muktadir Mia informed that seeing launch caught in imbalance position he shouted at the passengers to go to the lower Deck and advised the sareng to pull the launch towards the bank. But neither the passengers nor the sareng listened to him which caused the tragic death, he believes.

Baktiar Mollah of the same village informed that the illfated launch was operating between Khulna and

Satrujitpur for last one month on temporary basis. Another school boy of the village Shahin, 12, told that the incident took place just at ten past ten in the morning. The local people could not rescue the ill-fated launch due to heavy current in the



Local people also informed that the number of missing passengers would not go high as most of the passengers were boarding on the top of the launch and they managed to escape as it took place during day time.

## System loss reduced to 18.31 pc in 1994-95 against 41 pc in '92-'93

RANGAMATI, Aug 22 The Rangamati Distribution According to sources, out of Division (RDD)-II of Power the outstanding amount of Tk Development Board (PDB) has earned Taka 12.93 crore as electricity revenue in 1994-95 against supply of electricity to some 13,373 consumers within its network of supply covering an area of about 18,000 square kilometres, officials said. Due to constant vigilance Khagrachhari municipality

178 staff and officials of RDD, the system loss in the perimeter of its supply network has been reduced to 18.31 per cent in 1994-95 which was 41 per cent in 1992-93, said Wasiur Rahman, the Executive Engineer of RDD-II. claiming it as the lowest rate of system loss in the country. loss is 15 per cent, he added. Despite ceaseless drive towards realisation, an amount of Tk 5.84 crore has been lying outstanding against government and nongovernment agencies includ-

Besides supply of electric-

ity to Rural Electrification Board at Hathazari of Chittagong at the rate of Tk 11 lakh monthly, RDD has got more 10 electric supply units in the two hill districts of Rangamati and Khagrachhari including a considerable area in Rangunia and Raojan thanas of Chittagong district. The regular electric supply units headed by Resident Engineers are working independently under the administrative control of RDD-II at Kaptai, Rangamati, Khagrachhari, Manikchhari, Matiranga Betbunia, Dighinala, Marishya, Mohalchhari and Ramgarh, sources said.

The RDD's special squad disconnected about 4,000 power lines of the consumers for non-payment of electricity revenue timely including 400 in the month of June, 1995 alone, sources added.

# Launch dacoits chased, caught

SYLHET. Aug 22: Twelve armed dacoits while fleeing after committing a launch daceity in broad day light were caught by the villagers on Saturday. About 40 passengers were injured in the attack. The villagers recovered two pipeguns, wife daggers one ram dao 4 cartridges and some of the booty

from the fleeing dacoits. The passenger launch MV Arman was on its way to Aimiriganj having started from Sherpur ghat of Moulvibazar district in the morning. At about 11-45, when the launch reached near Fadullah of Nabigani thana, some dacotts who were in disguise of passen-

on the launch crews and some passengers. The dacoits looted valuables worth about Taka two lakh from the passengers. Some other accomplices on an engine boat also joined the dacoits in the launch. In the meantime, the clerk of the launch dived into the river and swam to the bank. The villagers soon gathered there as he made a hue and cry. One Aftab Uddin with his licensed gun boarded on a speed boat and chased the dacoits on the engine boat who were fleeing along with the booty, through a canal. After sometime the dacoits reached near the Raniganj bazar of Jagannathpur thana of Sunamgani district where they found no way to proceed due to a bamboo made bridge. The dacoits then opened fire at the chasers. There was an

exchange of several rounds of blank fires. At a stage the villagers also surrounded the engine boat of the dacoits. They caught as many as 12

out of 16 dacoits of the gang. One getting information, police from the Jagannathpur thana reached there and arrested the dacoits.
