Ershad should get severe punishment: PP

The government prosecutor vesterday sought maxi mum possible punishment for deposed president HM Ershad and two other co-accused in the special case regarding the refurbishment of an abandoned house as the Jativa Party (JP) office, reports BSS.

The prosecution concluded its argument on the fifth day yesterday. The defence argument is scheduled to begin today.

Public Prosecutor Abdur Razzak Khan sought the "severest" punishment for Ershad and his two associates as per law for the offences they had committed with regard to refurbishing an abandoned house in the capital by spending huge government money in contravention to set rules and abuse of official position.

Former works minister Mostafa Jamal Haider and former works secretary MA Rouf are co-accused in this

The house bearing in Dhanmandi residential area which has been refurbished at an expenditure of about Tk 82 lakh was used by Jatiya Party as its central office till the fall of Ershad.

The PP said that Ershad. the principal accused in this case, holding the highest position in the state, acted most irresponsibly to get the work done by issuing verbal instructions. He obtained benefit out of the huge expenditure of the state. Khan

Zinat Ara, Additional Session and District Judge (First Court). Dhaka was presiding in the special judge's court which is housed in the first floor of a building opposite to the Dhaka Central

The defence declined to start argument on behalf of the accused persons when asked by Judge Zinat Ara. Yusuf Hossain Humayun, counsel of Haider said that since the chief counsel of the principal accused is absent, the argument should be started tomorrow. She gave her consent to the prayer and adjourned the proceedings till today.

The PP charged that Haider aided and abetted the principal accused which led to illegal and unauthorised extravagant expenditure. Rouf being the principal accounting officer of the ministry instead of preventing them allowed the unusual spending to take place.

Accused Ershad committed an offence of unusual dimension and acted in a very irresponsible manner.

and deserves severest punishment as allowed under law, the PP argued.

Jatiya Party and its predecessor Janadal which occupied the house since 1984 never paid any rent, according to admission by the defence in the court.

The PP mentioned that besides civil and other works encompassing massive renovation and refurbishing, fund from state exchequer was also used to buy 10 airconditioners and furnitures and other accessories worth over Tk 16.24 lakh for the house.

He wondered how public money could be spent in supplying carpet worth over Tk 2.16 lakh for the house which was used by the political party. The articles which were supplied as furniture and accessories included even towels and flower vases.

There were 20 prosecution witnesses in this case while the number of witnesses from the defence side were 10 who included former prime minister Mizanur Rahman Chowdhury.

The PP reminded the court that as per government rule, one per cent of the valuation of an abandoned house could be used for repair. He said after spending huge money the valuation of the house was fixed at Tk 1.34 crore, therefore the refurbishment expenditure should have been Tk 1.34

- Besides spending huge public money for a political party, services of a large number of government officials from chief engineer down to petty officers were employed in the work demonstrating the abuse of power by the accused persons. As for the finance minis-

ter's permission (the no objection certificate to carry out the work), the PP said it was given subject to the fulfilment of several conditions. There was a number of 'ifs' which were to have been met, he said adding that the "finance ministry was misled in awarding the permission.

Khan said it is true that the house in question is a government property. But it was not used for the purpose of the government, but for a political party, he said.

He asserted that the prosecution has enough materials to prove beyond any reasonable doubt that because of the unlawful instruction and abuse of positions by the accused persons, huge fund from the state exchequer was spent for the benefit of a private party.





CHICAGO, Aug 22: Subrahmanyan Chandrasekhar, whose groundbreaking theories on astrophysics won him the Nobel Prize in 1983, died on Monday, the University of Chicago announced. He was 84, reports Reuter.

Chandrasekhar, who had been affiliated with the school for a half century, died of heart failure at the University of Chicago hospi-

tal, the announcement said. "Chandra was one of the great astrophysicists of our time," said fellow Nobel Laureate Hans Bethe of Cornell University in a statement. "He showed that white dwarf stars cannot grow beyond a certain mass, the same mass that triggers the explosion of supernovas.

Awami League chief Sheikh Hasina has asked the ruling BNP to concede to the Opposition demand for a caretaker government by August 31.

The loose alliance of Awami League, JP and Jamaat has called for countrywide 32-hour hartal September 2-3 to back up their demand.

Solar PV panels to help solve energy crisis

The country's energy crisis can be met by installing solar photo voltaic (PV) panels on roof tops, at a very moderate cost, speakers at a seminar in the city said yesterday. The government and sev-

eral NGOs have already installed such solar energy systems successfully in some villages of the country, the speakers said.

"The government is now framing an energy policy, the first of its kind in the country, to make solar energy in the off-grid areas available at low cost" said Energy and Mineral Resources Minister Dr Khandker Mosharraf Hossain. While inaugurating the seminar.

It was disclosed at the seminar that energy can be reached to 80 per cent of rural non-grid areas of our country by proven alternate renewable energy sources.

Presided over by Aziz-ul Hag, former advisor to the government, the seminar on "Application of solar Energy in Bangladesh" was also addressed by Rashed Maksud Khan, president of the Dhaka Chamber of Commerce and Industries. Afroze Rahim, chairman. Rahim Afroz Bangladesh Ltd. Prof Muhammad Ibrahim, director, renewable Energy Research Centre. Dhaka University and Dr Abdullah Al Muti Sharfuddin.

The key-note paper was presented by Dr Sajed Kamal. President. International Consortium for Energy Develop-

ment, a Boston-based nonprofit corporation. The seminar was organised by the Dhaka Chamber of Commerce and Industry (DCCI) in coo-operation with

the Human Development

Foundation.

Explaining various aspects of using solar energy in our country, the energy minister said. "Our region is blessed with a rich sunshine, and solar radiation is now being applied for domestic and industrial heating, cooling, drying of fruits, grains and vegetables seasoning of timber. generation of electricity for homes, cars, and even for the electric grids. So, there is no reason why we should not accept it and go ahead" he

noted. demonstrate the work ability and social acceptability of solar energy the Rural Electrification Board, with the financial help of the French government, has undertaken the pioneering venture to set up the first ever pilot solar village in Narsingdi district", the minister informed the seminar.
