COX'S BAZAR, Aug 30: The much-awaited Bangladesh Myanmar border trade com mences from September 5.

The governments of the two countries have already taken necessary preparations to start the border trade. which is expected to usher in a new era of economic coop eration between the two neighbouring countries.

This was stated at a meeting at the office of the Deputy Commissioner (DC) of Cox's Bazar today. DC Sheikh Mohabbat Ullah, was in the chair.

According to official sources, the border trade was initially scheduled to commence from September But the date was shifted considering the weekly holiday on September 1 and the call for hartal on September 2 and 3.

Commerce Information Minister M Shamsul Islam will inaugurate the border trade on September 5. Fisheries and Livestock Minister Abdullah Al-Noman and Myanmar's Minister for Commerce Lt Gen U Thun Khée will also attend the function, to be held on the bank of the Naf

The commerce ministers of Bangladesh and Myanmar signed the border trade

agreement in Dhaka on May

18 this year Under this agreement Bangladesh will import rice. pulse, shrimp, cement, quality timber and bamboo from Myanmar while Myanmar will import a wide range of products from Bangladesh

It is hoped the border trade between the two countries, which shared a common border across the Naf river, will significantly reduce smuggling across the Teknaf border.

"We still demand that the loan defaulters and plunderers of national wealth be barred from contesting any polls."
