Recently an exclusive, privileged set of people got to witness a fashion extravaganza (referred to as a "fashion hungama" in the ads) in town. BATEXPO 95 featured the most talked about fashion show of the year held at the Hotel Sheraton. The show received rave reviews from many local newspapers, but this write-up begs to differ. It advocates that you swallow all the hype of such events with a pinch of salt; and offers a word of caution to the wise : in future when you buy Tk 3000 tickets to front row seats in a fashion show, make sure you pay the amount in dollars in NY or Paris or someplace else where they know what they are doing. "They" mean the organizers, the publicists, the apparel manufacturers, the choreographers, the models, the designers

The evening was pleasant, the ambience promised an exciting night ahead, anticipation was reaching a crescendo as people started to trickle in at the scene. The volunteers assigned by the organizers mingled with the crowd to show people to their seats. At times they mingled a little too much with their acquaintances in the sea of faces and got engrossed in animated conversations neglecting the confused, unlucky ones who had to search for the right seats all on their own.

After a long wait and a nice display of lights, the show got under way when everyone's enthusiasm had thawed a little. Long waits always tend to do that.

A popular folk song filled the air as some girls in plain silk sarees paraded in sporting flower adornments. They wore different coloured sarees but all of them had one common element, a plain, cotton black blouse, ill-fitted at that. How that qualified as a fashion statement eluded the audience.

The girls paraded endlessly until the song came to an end. Next came the boys in a trendsetting ensemble - sleeveless Tshirts, jeans, black glasses and ties with a yellow flower tucked into the knot. We know (and so do many accomplished people familiar with the fashion world) that designers design a few ensembles and accessories for the sake of creativity but the general public were far from appreciative. Even some foreigners could be seen bursting at the seams. The models appeared tense, uncomfortable, wobbly and not too sure of the next move. They needn't have worried what with the monotonous marchpast-like choreography where they had to hurry from one and of the ramp to the

other. They rushed to and fro as if their life depended on it.


The following ensembles were familiar to the point of being boring. Oversize Tshirts long out of vogue; green faded jeans were never quite 'in' to be 'out' now; ill-fitting dress shirts: lepsided baseball caps and slip-dresses not tapered enough to compliment the wearer on top of that prudish shoes badly needing a thorough polish were put up for display Regarding the RMG line, the designer really can't be held accountable since she had limited options to work with. But the question is why parade around in a fantastically out-dated boudoir and call it a 'fashion hungama'?

This is where the innovative creations come in. However one has to be honest about one's feelings even if they don't conform to the politically correct standards. The crowd of laymen present found it hard to appreciate a man in a shalwar (or, was it baggy trousers, also out-of-vogue) and a fatua made of a material similar in appearance to that of the widely used striped cotton piece of cloth used in the rural areas or by the urban poor as a towel. Maybe, this particular version is finer in quality, finish or durability but it still resembles a "gamcha" to the deshi eyes and to the foreign buyers it's a badly made, chaotically striped pair of baggy trousers predominantly red in colour. Being seen in public in one such outfit could spell the doom of one's social life.

One good thing about the show was the imaginative choreography arranged to the track of another folk song. The crowd appreciated it greatly, specially the youngest model who mesmerised the audience with her effortless dances and adorable smile. The little girl virtually had the public wrapped around her little finger.

When the show finally came to an end with an incompatible mixture of George Harrison's Bangladesh and a folk song (Tak Dhin, Tak Dhin Bajai), the performers got off the stage and once out of sight (but very much within earshot) they let out shrill cries of jubilation and screams and cheers to commemorate their supreme success. The hullabaloo left the audience dumbfounded and at a loss. They deserved the cheers, though. They had just finished the fashion fiasco of the season. That was no mean achievement. What if the people didn't understand!
