agreed to halt the expulsion of Palestinians, but the fate of 1.000 of them stranded in a no-man's land on the border with Egypt has yet to be resolved, the Arab League said today, reports AFP.

"The Arab League continues to use its good offices to settle the problem of Palestinians who have already been expelled," and been stranded since the start of October. assistant secretary general Said Kamal told AFP.

He said an agreement between Cairo and Tripoli announced here last week applied to Palestinians still living in Libya but not the stranded.

Libva has "committed itself not to carry out any further expulsion of Palestinians following the Egyptian efforts," he said. "We hope these efforts will allow the

> Egyptian Foreign Minister Amr Mussa, after meeting Libyan leader Moamer Gaddafi, said Friday they had agreed to solve within two weeks the problem of the 1,000 stranded Palestinians living in tents.

But Libyan state radio denied any such accord.

Mussa said Gaddafi had also agreed to "suspend his decision to expel 30,000 Palestinians living in Libya," a process launched in September to show the Israeli-PLO autonomy accords have failed to produce a Palestinian homeland.

At least 5,000 have already left the country while a further 1,000 have been trapped in a tent camp set up by the Libyan authorities.

reach an understanding on the composition of an interim government within a month. Otherwise, the government has to take unilateral steps as per the dictates of the Constitution," the BNP leader said. According to the Constitu-

tion, the Election Commission (EC) has to hold byelections for 141 vacated Opposition seats in Parliament on or before December 17 this year and has to announce the schedule for the by-elections some 24 days ahead of the polls.

If the ruling party prefers general elections after completion of its full term, the EC has to hold the polls at least 90 days before April 5 next year. Because, the present Parliament had its first meeting on April 5, 1991 and the five-year tenure of this government therefore ends, on April 5.

Bhuiyan declined to say anything on whether the government, in case of no understanding between the contending political camps, would go for by-elections or

general elections. He said that the Prime Minister was still ready to step down 30 days before the general elections. "What we need now is to decide, through discussion with the Opposition, the composition and terms of reference of the interim administration."

When asked about the fate of the move taken by the

group of five intellectuals, for dialogue, Bhuiyan said that he had a discussion with the group yesterday (Monday). "I am optimistic about the move. They are to meet the Prime minister, for the second time, this evening." He told the newsmen that the intellectuals had not yet put forward any outline for an interim government.

Replying to a question. Bhuiyan said the BNP would not accept anything beyond the constitution. When asked whether his party would accept a non-partisan, neutral personality as head of an interim cabinet, he said "There could be no neutral personality as such."

Referring to Sheikh Hasina's demand for elections with a fresh voters' list Bhuiyan said, "Preparing a fresh list needs a lot of time. But we are constitutionally obliged to hold national polls before April next year."

"There are reasons to apprehend that the AL chief wants, instead of elections in due time, a constitutional crisis."

Rejecting the Opposition allegation that the BNP people were misappropriating relief materials in the floodhit areas, Bhuiyan said the ruling party had nothing to do with the distribution of relief goods. "The army and the civil authorities are in charge of distributing relief and the government has been providing relief goods on their demand."

"We are in agitation for a neutral caretaker govern ment and we will take the revenge of this killing, by realising the demand for a caretaker government by establishing people's rights, to vote and food," the Awami League chief told the protesters.

Hasina reasserted that no elections would be allowed under the BNP government and called upon the people to continue the agitation to unseat the government.

Later, the Awami League activists got dispersed from the gathering in small procession while the body was taken to Dhanmondi area.

Earlier, party leaders Abdus Samad Azad, Zillur Rahman, Amir Hossain Amu and Mozaffar Hossain Paltu addressed the protesters in front of the Press Club and led the procession towards the Science Lab.

Sanjay Dutt gets bail

NEW DELHI, Oct 16: India's Supreme Court today ordered Sanjay Dutt, a boxoffice idol who towered over the world's biggest film industry, to be released on bail after spending over a year in jail in a Bombay bombing case, reports Reuter.

The 36-year-old actor. who earned fame in a string of anti-hero roles and is said to be now suffering from a lung disease, was first arrested in April 1993. He was released on interim bail within a month but re-arrested last year under strict-anti-terrorism law that has since lapsed.

"We allow his application for bail," a three-judge panel said in its ruling, which ordered Dutt to provide 1.5 million rupees (45,000 dollars) in bail and financial guarantees and to surrender his passport.

The judgement was a victory for one of India's bestlike film heroes whose long legal struggle and health problems have been played out on the front pages of the nation's press.

Three different courts, including the nation's High Court, had turned down seven previous bail applica-

Long-haired and wiry, Dutt was arrested after two suspects in a series of 1993 bombings in Bombay said the film star had illegally bought and assault rifle from them. The bombings killed some 260 people in Bombay, In-

dia's commercial capital. Dutt, whose mother was a prominent Muslim film star and his father an actor turned politician, said he bought the rifle for protection during riots in Bombay which proceeded the bomb-

Ironically, Dutt wielded similar weapons in several of



his violence-laced movies. produced in India's film capi tal Bombay, known as "Bollywood." The industry makes a many as 800 films a year. more than Hollywood or any other production centre.

Dutt was granted interim bail in May 1993 but taken into custody again and jailed in July 1994 while he awaited trial along with nearly 200 others charged with crimes in connection with the Bombay serial bombings.

Meanwhile, the Motor Sramik Union called a halfday hartal in Shajadpur thana tomorrow protesting the attack on their office.

Serb leaders locked in power struggle Gvero, Zdravko Tolimir, Djor

SARAJEVO, Oct 16: Bosnian Serb leaders were locked in a power struggle today as the breakaway region's parliament, angry at battlefield losses, demanded the dismissal of generals loyal to army commander General Ratko Mladic, reports Reuter.

A marathon session of parliament ending in the northwest town of Banja Luka early today accepted the resignation of figurehead Prime Minister Dusan Kozic as a political scapegoat for military defeats in northwest Bosnia.

The more significant demand for the dismissal of four generals, by deputies of the ruling Serb Democratic Party (SDS), appeared to signal the revival of a power struggle between Bosnian Serb President Radovan Karadzic and Mladic. On the military front, UN

officials in Sarajevo said fighting appeared to have stabilised in the northwest, and expressed confidence that the ceasefire in force since Thursday was holding along the vast majority of the front

The call in parliament for the removal of generals Milan dje Djukic and Gruja Boric followed charges by Karadzic that military leaders were partly to blame for the loss of 11 towns and 4,000 sq km (1,500 sq miles) of territory in northwest Bosnia to Muslim-led government troops and their Croat allies. Karadzic's own power in

the breakaway state has been compromised since he was forced to let Serbian Presi dent Slobodan Milosevic ne gotiate for the Bosnian Serbs at international peace talks.

Last August, Karadzic tried to dismiss Mladic but had to back down when other generals pledged loyalty to In Sarajevo, UN spokes-

man Lieutenant Colonel Chris Vernon said that, while fighting was continuing in the northwest, no land had been gained and overall the ceasefire was holding well. He said the UN Bosnia

commander, General Rupert Smith, was convinced the situation in the northwest was stabilising, and did not pose a threat to initial peace talks between the warring factions due to take place at the end of the month.

The radio, controlled by Rabbani loyalists, did not specify how and in which area of Herat the helicopter was shot down.

From Page 1 value of Letters of Credit (LCs) opened during last fiscal year aggregated to 6.8 billion dollars showing an increase of nearly 57 per cent over those of 1993-94. On the other hand, export grew by only about 34 per cent leaving a big gap. The total export earnings of the country stood at 3.4 billion dollars last year against previous

year's 2.5 billion dollars. Mahmud said, "Although the foreign reserve position is comfortable, the present rate of increase in import spending is not sustainable.
