180 shops gutted: Goods worth Tk 3cr destroyed

From CHT Correspondent MATIRANGA. Khagrachhari. Nov 14: At least 180 shops of different disciplines in Matirangabazar at Matiranga thana headquarters of the district were gutted and 30 persons sustained burn injuries in a devastating fire which broke out here at night following Monday last. officials said.

The cost of the properties and merchandises damaged by the fire havoc, which continued for about four hours was estimated around Taka three crore, unofficial source quoted the victims as saying.

On getting the information, the fire fighting team reached the spot from Khagrachhari district headquarters within 45 minutes and put out the fire in collaboration of the local people in about two and a half hours, the Thana Nirbahi Officer of Matiranga said.

The 180 shops gutted in the havoc included rice husking mills, rice and grocery shops, clothes shops as well as shops of other disciplines.

The fire originated from electric short circuit, when an electric iron of a tailoring shops exploded, while working at the west row of the market. victims said.

The victims lost every thing in the fire havoc and are passing their days under the open sky, it was observed.

On the following day of the havoc. Tuesday last, the Chairman of the Khagrachhari Hill District Local Government Council Samiran Dewan distributed Taka two lakh in cash from the council fund among the victims and assured them for their rehabilitation. The leaders and the activists of different political parties also visited the fire victims and

consoled them Commercially important in the district with largest population. Matiranga thana is yet to have a fire service station.

MOULVIBAZAR, Nov 14: Unnatural death claimed eleven lives in Moulvibazar district in the month of October.

According to the sources of different police stations of the district, two persons were murdered, one was electrocuted, one was run over by train, one drowned, one killed as a wall collapsed. three were killed in separate road accidents and rest two committed suicide.

During the month Kamalgonj thana of the district was at the top of the list of unnatural deaths with four cases.

It was reported that a businessman was killed by some unknown miscreants at village Badar-deul of Kamalgonj thana.

The victim Lukman Miah. 24, was called out by the assailants from his residence and slaughtered on October 5 last. Later, police recovered the body and sent it to Moulvibazar Sadar Hospital for autopsy. A case has been filed with Kamalgonj PS in this connection.

An unidentified youth was run over by a train at Murirgul area on Kulaura- Shabajpur railway section on October 7 last. An unnatural death (UD) case was registered with Kulaura GRP police in this connection.

A motor-cycle rider was killed when he lost his control and his bike dashed against a bridge at Bhuai area on Kulaura-Baralekha road.

The victim was identified as Abdul Motin, 40, son of Sirajuddin of Mohammedpur village under Baralekha thana. He was residing abroad and came to his home only few days before his death.

One Kona Miah, 45, was

killed when rival group attacked him with deadly weapons over the issue of a land at village Majompur under Kulaura thana of the dis-

trict on October 16 last. According to police, a long standing disagreement were continuing between the victim and another Abdul Basit of the same village over the possession of a land. Only three days before the incident, this disagreement was solved by a village 'shalish' where elites of Kulaura thana attended A murder case was filed

with Kulaura PS in this connection, but none was arrested till writing of this

One person was killed and twelve others were injured on Moulvibazar-Kulaura road on October 26 last.

According to witnesses, when a tempo bound for Moulvibazar hit a rickshaw near Kadamtala area of Rajnagar thana, the victim Jitendra De, 35, a tempo passenger died on the spot while another passenger Rafique was brought to Moulvibzar Sadar Hospital in a critical condition. Other injured persons were released after first aid.

A minor boy was killed when a portion of earth wall of their house collapsed on him at village Kalenga under Sadar thana on October 16

The victim aged about 4 was the son of one Abul Miah. A UD case was registered with Kotwali police in this connection. A six year old son of one

Jitendra Goap of village Padunapur at sadar thana drowned on October 16 last.

Family sources said he slipped into the pond while

playing on its bank. The body was later found in the pond. An youngman was electrocuted at the Laskarpur village

under Kulaura thana. According to report, the ill-fated persons named Sufian Miah, 25, son of Monnaf Ullah of the village Mustafapur under Sadar thana was electrocuted and injured seriously while he was engaged to fitting a pipe in the residence of Mrs Farida Begum. lecturer of Kulaura Degree College. He was immediately taken to Kualura Thana Health Complex where the Physician on duty declared him dead. A UD case has also been registered with Kulaura Police Station in this connection.

Besides this an young woman of Fulbari Tea Garden under Kamalgani thana committed suicide. Another young woman committed suicide at the residential quarter of Bangladesh Biman Bahini-Shamsernagar unit under Kamalgoni thana. A minor by of Kurma Tea Garden under the same thana was crushed under the wheels of a running car. Three UD cases were filed in these connections.

It was gathered that, unnatural Death (UD) cases has been filed following the incidents like suicide, road accidents, secret murder or other incidents. But for want of proper investigations, mysterious behind these cases remain unearthed. Fate of UD cases was always appeared with uncertainty. According to some allegations made by the family members of victims. These cases after recording as UD case with police stations, are not properly investigated into.

SYLHET, Nov 14 : An amount of Taka 26 crore 43 lakh 75 thousand has been lying unrealised in the four districts of Sylhet Division as electricity bills. The Sylhet circle of Power Development Board is comprised of five divisions.

tem loss here was estimated According to the reports, to be at 28.8 per cent, per 10 crore 31 lakh 13 thousand units of electricity was brought to the region from The division realised a total the National Grid during the first three months of fiscal year 1995-96, that is from the month of July till September last. Of the total, 8 crore 23 lakh 32 thousand units were sold to the consumers. The system loss during the period stood at 23.49 per cent the source added. A total of 14 crore 46 lakh 27 thousand was realised as electricity bill during the period. The total number of consumers in the circle now stands at more than 99 thousand throughout the circle.

The five divisions of PDB are Sylhet Division comprising the eight Electric supply areas of different thanas of Sylhet district and five electric supply areas of Sunamganj district, Moulvibazar division comprising four electric supply areas of Moulvibazar district and three electric supply areas of Habiganj district. Sales and Distribution Division-I Sylhet Sales and Distribution Division-II. Sylhet and Sales and Distribution Division-III Sylhet. The three Sylhet divisions are covering the Sylhet town and its adjoining areas.

Of the total amount of outstanding, Taka 6 crore 66 lakh 90,000 has been lying unrealised in the four electric supply areas of Moulvibazar district and three electric supply areas in the district of Habiganj. These are. Kulaura, Shamshernagar, Barlekha and Moulvibazar in Moulvibazar district and Ajmiriganj, Baniachang and Habigani Electric Supply in the district of Habiganj. During the said period. 4 crore 10 lakh 28 thousand units of electricity were brought to the division from the National Grid. Of this, 3 crore 60 lakh 80 thousand units were sold to the consumers during the period from July to September last. The system loss was estimated here at 1157 per cent. During the period, an amount of Taka 5 crore 44 lakh 13.000 was realised in the division.

In Sylhet Sales and Distribution division, the total amount of outstanding bills was at Taka 4 crore 48 lakh 22,000, till the month of September, this year.
