Tragic death Clashes over possession of charlands: 30 killed

BARISAL, Dec 19: The armed lathials backed by influential jotdars and richmen of different villages and charlands of the southern districts, as every year, become active in the areas.

Nearly one hundred people, mostly innocent helpless farmers have been injured and about 20 to 30 people died during different clashes over possession of the disputed khashland or charlands by the armed lathials during last two months.

Not only the armed lathials, sometimes in some areas, the outlawed party men, Sarbaharamen also attack and injure the innocent farmers backed by local influetial rich landlord to grab more land illegally.

Many farmers of different areas said, these armed lathials also set houses on fire, ransack, loot and sometimes rape the female members of the farmer families.

Furthermore, dispute over demarcation of districts border lines still exists, which naturally help the landlords to grab lands forging documents and deploying armed lathials.

It is revealed the char areas of that six districts of Barisal, Patuakhali Bhola, Borguna, Jhalokathi and Perojpur under Barisal Division eventually became hot bed of

bloody armed clashes between the peasants and hired lathials during this time of harvesting season every year

and it is going on unabated. In some cases, it is alleged, landlords, politically or some how powerful, get support from policemen to take possession of char areas through forged documents where clash becomes inevitable.

It may be mentioned here that there are disputes which sill exist over the demarcation lines in between Barisal and other districts of Bhola and Laxmipur districts. This dispute helps the lathials to set reign of terror in borderline char areas.

The land survey directorate, in the meantime, pitched pucca pillars in the charland between the Charveduria Mouza along the borderlines at Gaguria under Mehendiganj thana of Barisal and char Bheduria under sadar than of Bhola and thus a longtime problem was solved.

Through filing cases, different sorts of problems are being continued in different char areas in the southern districts. According to local sources, so far the cases are not being settled, influential people with their armed musclemen are taking possession of the charlands and reaping the paddy forcibly,

armed clashes with the farm-

The farmers and poor people living around the char area live in fear of sudden attacks by the lathials.

Places where clashes frequently occur are Charkilla, Char Bijali, Khagarcher, Chaiga, Bishkatali, Charmaijari. Kulargaon, Mandhyattar Kushria, Baburchar of Hizla thana, Dakatiachar, Miarchar, Kutubpur. Charveduria, Charpadma, Khalasirchar, of Muladi thana, Gaguria, Medua, Purbakazi, Chatkimara, Kenua, Udayapur, Charkilla, of Mehendiganj thana under Barisal district, while sadar thana area of Bhola including char Sitarampur, Shyampur, Charveduria, Ramdaspur, Charsatyen, Talchar, Charpatila, Char Kurimukri, Char Manika, Char Bastania, Char Kalmi, Majher Char. Char Mangal.

Meantime, according to reports received here, many clashes have already took place over possession of disputed land and repaying of paddy among the farmers, lathials, hired musclemen and the landlords in different places of Barguna, Bhola, Perojpur and Patukahli districts during last month.

Meanwhile, at least twenty new police camps have already been set up in different thana areas of Bhola, Patu-

The FFs had to face attacks from Sarbaharamen and Pak army

BARISAL, Dec 19: Barisal, the Venice of the East was liberated on 8th December, 1971. And the people of Barisal took breath of relief after long 225 days since Barisal was occupied by the Pakistani occupation Army on 27th April, 1971.

On that day the Pak Army through combined operation from land, river and air captured Barisal town a month after attacking the capital Dhaka.

Pakistani military convoy marched towards Barisal town along the Barisal-Faridpur highway on April 24. On way to Barisal they faced first resistance at Gournadi, some 26 kilometres from Barisal on April 25 morning by a small group of 20 Freedom Fighters armed with 303 rifles. It was the first resistance against Pak military on way to Barisal by the Freedom Fighters where they were locked in a face to face encounter. And in that place FF Syed Abul Hashem, Moktar Ali, Alauddin and Parimal were killed.

At the same time Pak paratroopers were also dropped at Taltali, a place outside the town area where some innocent villagers were killed. Through river routes well equipped Pak Army proceeded towards Barisal on gunboats. At Junahar, near Barisal the army were resisted by the FF on two wooden steamers and a couple of 303 rifles. Unfortunately the steamers were sunk and the resistance broke down.

Capturing Barisal, Pakistani troops setup their headquarters for Barisal zone at the then WAPDA office building in front of Barisal Medical College. Later they made bunkers around the building, torture chambers, jail and armoury camp.

After the fall of Barisal district headquarters Freedom Fighters who were grouped in one. The Freedom Fighters formed separate groups in different places of the district. These small groups of Freedom Fighters had to face both. the armed dacoits and the attack from Pakistani army

Some of the FF groups of the then greater Barisal district were led by Kuddus Mollah at Mehendigani, Jafar and Majibar Rahman Talukdar at Bakergani, Jahangir Bahadur at Swarupkanthi, AFM Hemayet Uddin and Haranath Bain (former MP) at Uzirpur. Nizamuddin Ahmed at Gournadi. Bentlal Dasgupta and Mohiuddin Manik at Banaripara, Arab Ali Mia at Dehergati, Abul Kashem, Majid Khan and Abdul Wahab Khan at Babugani, Sultan Master, Ratan Sharif and Abdul Mannan at Kotwali, Siddigur Rahman at Bhola Gazi Mokim Ali at Naichity.

From June to August '71 Comrade Siraj Sikder of Sarbahara party built resistance against Pak army at the Guava Garden of Swarupkatli.

In August Captain Sahajahan Omar came to Barisal fleeing from the then West Pakistan Army camp and was appointed as the first Sub Sector Commander by the exile Government. He first set up the sub sector headquarters at Dargabari of Barakatha village of Uzirpur thana of Barisal on September 6, 1971 from where operations were conducted against the Pakistani troops. Then many brave youngmen were sent to India for guerilla training from there.

In November after so many face to face encounters between the Pak Army and Freedom Fighters in different places Banaripara was captured by Jahangir Bahadur. Later Swarupkathi and on 6th December Bakergani was captured by FFs. During these attacks 10 policemen and Mustaque including some other FFs were killed.

December 8 was the Victory Day for the people of Barisal In the morning military, civil, razakar, albadars commanders of Barisal were informed about the fall of Bakergani thana.

They then met at a secret meeting with the peace committee members in the headquarters. There they decided to leave Barisal in the existing curfew hours. They left Barisal towards Dhaka on two steamers, two gunboats and a passenger launch.

Surprisingly air raids by Indian Air Force was conducted in Barisal at 2 pm on that day. Later when the news spread that enemy had left the town people from all walks of life came out on the streets to celebrate the victory. People gathered on the streets and shouted slogans 'Joy Bangla'.

In the afternoon Freedom Fighters from different areas entered the town celebrating victory with the people. As soon as the Freedom Fighters entered the town razakars and albadar started seeking shelters leaving their arms.

Captain Sahajahan Omar with his men reached Barisal from Padri Sibpur in the town.

People of Barisal surrounded the enemy in the WAPDA colony till December 15. On that day Nurul Islam Manjoor. the then civilian chief of the sector 9 asked the military and their alliances to surrender. They surrendered on December 17

The greater Barisal district was under the 9th sector

command during the Liberation War. After the independence Captain Sahajahan Omar was awarded the title 'Bir Uttam" while "Bir Pratik" to Mohiuddin Manik for their outstanding and valiant performances in the Liberation War of 1971.

But there is no arrangement for the education of these children who are innocent but compelled to live in jail for their mothers' fault.

According to jail authority the ward is always filled up by about 60 arrested and imprisoned women with whom 10 to 12 children are compelled to live. Besides, many babies were born in the cell deprived of getting open air of the world.

Moreover, the women prisoners are living in a deplorable condition as all the three pans of toilets were broken down and the water supply is less than its de-

The women prisoners urged the authorities to provide them with basic amenities in the jail.
