Citizens' rally demands RU VC's removal

RAJSHAHI, Dec 30: A citizens' rally organised by the Rajshahi University Teachers' Association (RUTA) recently demanded removal of Vice-Chancellor Prof Yusuf Ali for restoring normalcy on the varsity campus, reports UNB

The meeting, held in the district council auditorium with RUTA Vice-President Prof Abdulla Ansari in the chair, decided to submit to the Chancellor a memorandum of the demand for removal of the VC.

Speakers at the rally, at tended by local political leaders, cultural activists, professionals, intellectuals, newsmen, students and city elite, accused the VC of patronising the Jamaat-Shibir axis which bred unrest at the university.

The university has long been closed since the latest round of clash between Shibir and APSU activists on the violence-ridden RU cam-

The rally was addressed by RUTA General Secretary Dr Mizanuddin Ahmed, first RUCSU VP Bazlul Karim, former RUCSU VP Fazlev Hossain Badsha, city Awami League President Moniruzzaman, city BNP Organising Secretary Adv Ershad Ali Isha, Enamul Hug of CPB and Shafigur Rahman Badsha of Gano Forum.

Dacoits stab old man to death in Magura

MAGURA, Dec 30 : An old man of Rupdah village in sadar thana was stabbed to death by dacoits on December 20 last when he tried to resist them, reports UNB.

Police said, a gang of seven dacoits stormed the house of Golam Mohammad and beat the inmates of the house mercilessly. But when Abdul Gaffar, 50, a member of the house, tried to resist the dacoits they stabbed him to death.

The miscreant decamped with Tk 8,000. A case was registered and police investigation is on.

Another report says : A young man of Katli village in Shalikha thana succumbed to his injuries on December 14 last after he was hit by da-

Police said, Musa Dofadar, 30, was attacked by the miscreants on December 11 last while he was keeping an eye on the deep tubewell at his cropfield at night.

The gang numbering about 10 beat Musa mercilessly and decamped with the tubewell.

Later, Musa was admitted to Shalikha Hospital, but he died on his way to Dhaka PG Hospital.

A case was lodged with the police.

Three killed, 25 injured in road accident

COMILLA. Dec 30: Three people were killed and 25 others injured when a bus hit a truck parked at Amirabad in Daudkandi thana on Dhaka-Chittagong highway on Wednesday last, reports UNB.

Huge quantity of forest resources being illegally extracted

MOULVI BAZAR, Dec 30: Kalachhera, Lauachhera, Chautali and Satgaon forest zones under Moulvibazar Range of the Forest Department are on wane due to illegal felling of trees by some gang of wood pilferer. According to allegation made by concerned people, due to pilferage of forest trees and negligence in duty of forest district. officials, environment of the district are on serious threat and the government is also being deprived of revenue

from the forest resources. In the meantime, market of pilfered wood is available in abundant in the district. Huge number of 'saw-mills' and 'furniture manufacturing factories have been set up at different places of the district. Main source of timber of these factories are illegal forest woods, it is learnt.

The forests of Moulvibazar district were full of valuable trees like timber wood, firewood, bamboos, cane and other old trees.

According to a survey, that was conducted last year in the district it reveals thattrees on 20 lakh acres of forest land were cut down during last two and half decades. It was also learnt that total forest areas of the district was 55.44 lakh acres earlier. However, the figure has come down to 35.50 lakh acres.

The official source of the district claimed that the total forests area now stand at 16.85 percent of total land in Moulvibazar district. But ac-

cording to the said survey it is only ten percent. The survey report further says that the ratio of afforestation and deforestation is 1:3. Meaning. one plant is being planted while three are being cut down. The ecologists said that, there must be at least 25 percent forest land for healthy environment in the

However, when the nation has paid attention to afforestation programme across the country, reserve forest in the meantime, of Moulvibazar district are being plundered.

Due to indiscriminate felling of trees, the environment has started to show some changes.

According to a source, some well organised gang of wood-pilferer are engaged to destroy our forest resources. These groups are being assisted by some middle and lower level forest officials of different forest offices. Most of these unscrupulous wood pilferer are always choosing some specific species of trees like, segun and gamai

It is also gathered that the timber wood which are pilfered from the reserve forests are being processed at different saw-mills and then these are supplied across the country. Consignment of such timber are being made though railway routes. Railway stations of Rasidpur, Satiajuri, Satgaon,

Bhanugachh, Tilagaon and Longla are commonly used by the powerful wood pilferers

for transportation. On the other hand, songrass and bamboos has also been pilfered from the reserve forests. These items are oftenly sold at different markets including Srimongal. Poor people of the areas are purchasing these items as there house-building materials and as fire-wood at Cheaper rates. When asked about avail-

ability of trader of son-grass and bamboo at Srimongal market-said, they purchased son-grass and bamboos from 'mohaldars' who collected those from forest. During a conversation with the traders they refused, to mention any names of such 'mohaldars' but added that these items are illegal one and each of the 'mohaldars' have an arrangement with concerned officials. Though the retail traders are giving tolls to different persons but they are secured.

An official of the Forest Department confess the allegation of wood pilfering but said, most of the local forest Department employees are poor and Moulvibazar district has a large area of reserve forest. According to him, there are 60 thousand acres of reserve forest in Srimongal area under only one Assistant Conservator of Forest (ACF). But this post of ACF at Srimongal is lying vacant for few moths. Another ACF from Sylhet office is looking after the Srimongal office for interim period. The acting ACF made his visit to Srimongal Forest Department as an extra duty but it is not sufficient for the need. The said forest official added that number of posts at different stage of Moulvibazar district forest department must be increased immediately for proper maintenance of our reserve forests. He also denies that wood pilferers have any link with any Forest Department personnel, but admitted that some dishonest people have been taking the opportunity of man-power shortage in the Forest Department.

However, the BDR personnel seized nine cubic feet of valuable timber-wood recently from different areas. Besides this, the forest officials also seized another 150 cubic-feet of timber. More than one hundred cases have been filed against the woodpilferers in Kulaura, Kamalgonj and Srimongal thanas during the period. A police office of Kulaura thana says they had been arresting some wood-pilferers at different time, but due to some weakness in existing forest-laws. the culprits are escaping allegations.

The authorities concerned should pay due attention to take preventive measures for protection of our forest resources of the district, it is widely felt.

It may be mentioned here that Freedom Fighter Rayub Ali, was allegedly beaten to death after being arrested by the police on December 6 last at village Daulatpur under Borolekha thana of the district.

After being arrested, Rayub Ali was allegedly tortured. People of the village rescued him and sent to union health complex where he succumbed to his injury. Agitated people detained the police team for few hours in the spot.

However, elder brother of the victim registered a murder case with Borolekha thana against the policemen. Besides this, Moulvibazar district administration constituted a probe-body with a First-Class Magistrate and an Assistant Police Super

In the meantime, the post-mortem report of the victim was received on December-12 last where it was stated that physical torture was the cause of death of the victim. After receiving the post-mortem report, it was decided by the police administration to arrested the said policemen including two officers.
