Trade relations between the United States and Bangladesh have been developing rapidly, especially since the take-off of Bangladesh's ready-made garment industry. The United States imported nearly 1.1 billion dollars worth of goods from Bangladesh in 1994, most of which (\$918 million) was garments and knitwear. Through July 1995 total im-

ports into the US from Bangladesh were up 36% over the same period in 1994; imports of garments were up 28%, and knitwear imports were up nearly 80%. Second in overall importance were frozen fish and seafood, totalling nearly \$100 million in 1994. The United States exported \$233 million in goods to Bangladesh in 1994. of which \$122 million was wheat, and \$29 million raw cotton. Through July of this year, imports of US wheat were running 127% ahead of the totals of 1994, and imports of US cotton were up a whopping 218%. Other growth items this year have been imports of US wood power/telephone poles, radiotelephone transmission equipment, generators, down feathers, aircraft parts, and looms. These are just a few of the very diverse group of

in the US Embassy Economic and Commercial Section is to increase and improve the trade relations between the United States and Bangladesh, especially through expanded exports of US goods and services. Many US companies are unaware of the real opportunities that await them in this market. They need to realize that Bangladesh is a growing economy with low labour costs. industrious people, and a policy of opening up to imports and to foreign investors. N the field of water qual ity and management the L basic major factor is maintenance of oxygen level both for the aquaculture as well as other water and wastewater treatment.

In the fields of aquaculture, unfortunately, due to some form of familiarity with splashing type and also it being too cheap price wise, aquaculturists of our country tend to use the common paddle wheel type aerators. regardless of durability due to several moving parts and problems of maintenance.

The effectiveness cost ratio wise is one thing; the common users do not much care for and are quite happy with paddle splashing on the water surface!

Other Aeration Systems

. Splashing-type systems that force water into the air consume enormous amounts of energy. The wasted energy might otherwise go to the addition of dissolved oxygen to the water. Also, the area of influence is confined and limited due to a lack of adequate water movement.

Blower/diffuser systems that introduce air into the water from the bottom of the pond suffer from poor oxygen transfer in shallow depths (less than 2 meters). The system clogs over time as solids and biofilm accumulate. This reduces efficiency and increases maintenance requirements.

The third US Trade Show held in 1994 had 38 exhibitors representing 80

The enthusiastic response from the visitors (30,000 in attendance) demonstrated that they were greatly interested with the fourth annual US Trade Show. The floor sales and orders placed exceeded US \$ two million. Further, the exhibitors main interest was exposure and creating awareness among general

public and that was achieved. The huge success of the US Trade Show '95 left behind scope for further development in this area so as to contribute toward growth of US trade and investment in

Bangladesh. We consider that the US Trade Show has been a very important event for those concerned with expanded relationships between the United States and Bangladesh. The ABEF has been continuing to organize the US Trade Shows in Bangladesh each year with the support of the United

States Embassy. Building upon the enthusi-asm reflected in the last four consecutive annual Trade Shows, particularly the US Trade Show '95 and also considering the importance of this kind of trade event, the fifth annual US Trade Show is being held at the Dhaka Sheraton Hotel from January 11-13, 1996. 
