### State Deptt on one-party polls

The United States wants a fully contested elections in Bangladesh as a spokesman says one-party election does not usually provide for fully participatory democracy, re-ports UNB.

"One-party elections don't in the abstract, obviously. provide for fully participatory democracy normally. That's correct." acting spokesman for the State Department Glyn Davies said.

His observation came during a briefing on Tuesday in Washington in response to a question whether one-party elections are non-democratic.

Commenting on February 15 general election, being boycotted by major opposition parties, the American spokesman said the US called on both the Opposition and the government of Bangladesh to end violence and intimidation over the poll issue.

"Our interest in that country ... is in seeing the democratic process proceed and we would like very much of course to see fully participatory elections occur," he said.

Asked whether the US recognises the February 15 one-party election. Davies said: "We'll wait until February 15, if there are to be elections, and see what happens ... But I can't speculate about whether we recognise or don't recognise."

## One-party polls to create illegal JS

Opposition leader Sheikh Hasina yesterday said "a oneparty farcical election" would only create an illegal parliament and a government without credibility both at home and abroad, reports

"That illegal government will not have any right to pass any law in that illegal parliament," she said while exchanging views with journalists from national dailies and news agencies at her party's central office before the iftar.

Hasina, who is leading the 22-month-old agitation for elections under a non-party neutral government, said the ruling BNP just wanted to pass the electoral race by holding a farce in the name of elections. "The government and its

subservient Election Commission must stop the elections ... This will not be an election at all, where about 90 per cent voters, I think, will not turn up at the polling centres," the Awami League President said Hasina believed, there was

still a scope for a solution of the crisis if "this farcical election" is postponed, the Prime Minister resigns and election is arranged under a neutral non-party caretaker government allowing all opposition parties and voters to join it.

The BNP government has no right to snatch the voting rights of the people on the plea of the Constitution," she said, adding that the government was talking about Constitution — but violating it time and again for its own interest. "The Constitution is for the people'

"None will be allowed to play with the basic rights of the people," Hasina said. "The government is going to stage a farce with the killers of 1975".

Referring to the killing of a Juba League worker in Jhalakathi during the combined arms recovery drive, the Awami League chief demanded return of the army to the barracks.

Likewise, she asked, will an election be acceptable to the people in UK if the Conservative Party goes to polls without the Labour Party and others?

The Awami League leader said elections under a neutral caretaker government was needed "to ensure full participatory polls" as wanted by the United States. "No democracy in the world can accept the February 15 election," she added.

Hasina feared that conflict and confrontation would increase gradually if the government holds elections on February 15, ignoring the people's demand.

About arms recovery drive by the army, Hasina said "the government put the army against the people in the name of arms drive ... in the name of election."

# Sonargaon Hotel incident: 28 held

Twenty-eight employees of the Sonargaon Hotel were arrested yesterday following a case filed by the General Manager (GM) of the hotel regarding Tuesday's incident in which 15 officials of the hotel were reportedly beaten

The arrested persons include President of the employees union, Dewan Nasimur Rahman, vice-presidents Alibuddin Gazi and Abdul Gani, joint secretary Delwar Hossain, sports secretary Ahsan Habib Khawaja and treasurer Mirza Akbar Ali. police said. The arrested include six outside the list given by the General Man-

Police are looking for the remaining of the 45 who have been implicated in the incident by the GM of the hotel.

Yoji Hamano, the GM of the hotel, in his First Information Report (FIR) filed with the Tejgaon thana, said between 25 and 30 outsiders entered the hotel lobby Tuesday with pistols, daggers, and other weapons and immediately some office bearers of the union and employees entered his office and started abusing him.

"I tried to pacify them. As a result they became furious and in presence of those out siders the above union bear ers started hitting me. Some of them started breaking the furniture of my office including the big glass panel. I had to run off through the broken window in order to save my life," he said in the FIR.

"At the same time a group of militant employees headed by Motahar Ali, organising secretary of the Union, and some of the union executives entered the room of Assistant General Manager Shahid Hamid and they started to beat him," mentioned Hamano.

"As a result he was severely injured and he had to seek medical help," he

The FIR also mentioned that Ali Eskandar Ahmed. rooms division manager. Ekarmil Haque, director of food and beverage, C K Rodriques. Cafe Bazar manager.
