## Moderate rainfall likely

Light to moderate rain is likely at a few places over Khulna, Barisal, Chittagong divisions and at one or two places over Dhaka, Rajshahi, Sylhet divisions in the next 12 hours till 6 pm today, reports UNB.

Met Office says the sky is likely to remain partly cloudy. Day temperature may rise by 1-2 degree Celsius across the country.

Country's highest temperature 33.6 degree Celsius was recorded at Dinajpur yesterday and the lowest 25.2 degree at Feni.

Meantime, Madaripur had the highest 46 mm rain during the last 24 hours till 6 am yesterday. Rajshahi experienced 16 mm, Tangail 13, Barisal 12, Chandpur 8, Dhaka 7, Satkhira 5 and Khulna 5 mm shower in the period.

Former city Awami League vice-president and renowned social worker Mohammad Kalimullah died early yesterday at his Lalbagh residence. He was 78, reports UNB.

Kalimullah, who died of old age ailments, was a close associate of Bangabandhu Sheikh Mujibur Rahman. He has left behind his wife, 7 sons and 3 daughters.

His namaz-e-janaza will be held at Amligola Maidan after Magreb prayers. Later, he will be buried at Azampur graveyard.

Prime Minister Sheikh Hasina visited the residence of the late Awami League leader in the afternoon.

She spent sometime at the Amligola residence of Kalimullah and consoled the members of the family of the deceased leader.

Hasina was deeply shocked at the death of Kalimullah and expressed her heartfelt sympathies for the members of the bereaved family.

The Prime Minister prayed for salvation of the departed soul.

## Khaleda visits late Al Masood's family

Leader of the Opposition Begum Khaleda Zia yesterday visited the residence of former Secretary to the President Nooruddin Al Masood who died recently, reports UNB.

The BNP Chairperson conveyed her deep condolences to Begum Dilruba Masood and other members of the bereaved family.

Begum Masood, her sons Saud Bin Masood and Sabid Bin Masood and daughter Sidana Silmi Masood burst into tears to see Begum Zia at their residence, said a party press release.

Former state minister Begum Sarwar Rahman accompanied the opposition leader. Earlier on Friday, Begum Zia visited ailing party MP Giasuddin Quader Chowdhury at Suhrawardi Hospital. She spent some time with him and enquired about his health.

Chowdhury, suffering from heart ailment, was admitted to the hospital on August 6. He is under treatment of Dr Jalal Uddin.
