**BBS symposium begins**

Expansion of science education and development of technology will be given emphasis on the newly proposed education policy of the present government, reports UNB.

This was disclosed by Minister in charge of Education, Primary and Mass Education Division and Science and Technology ASHK Sadique while inaugurating a symposium on "Biochemistry and industrial revolution: Prospect and possibilities," at BARC auditorium yesterday morning.

Organised by the Bangladesh Biochemical Society (BBS), the symposium was also addressed by its president Dr Muhammad Hussain, general secretary Ishfaq Ahmed and Vice-Chancellor of Dhaka University Dr Emajuddin Ahmad.

The minister said necessary steps will be taken to improve the status of biochemical education and research in the country. He said biochemical research stands in the centre of all the endeavours of the new industrial revolution and the science of biochemistry which is only 60 or 70 years old now, compared with centuries old physics, chemistry and other branches of science, he added.

Sadique said the overall enrolment in science education to the higher education is not satisfactory. He suggested the science teachers to motivate students to adopt science subjects with their courses. Otherwise, the total goal of the nation could not be achieved, he added, said an official hand-out.
