Proposed Rupsha bridge still remains a dream

KHULNA, Aug 11: Nothing but a project office at Labonchora constructed at a cost of ten lakh taka bears an example of how the former government of Begum Khaleda Zia has de-ceived the people of Khulna in the name of 'Rupsha bridge': Because, there has so far been no progress at all even in doing the most ordinary works of the bridge during last five

According to a reliable source, one crore ninety lakh taka out of two crore taka was sanctioned during 1995-96 fiscal which has been refunded to the concerned ministry for failing to utilise it.

All previous governments made political commitments about the construction of Rupsha bridge — a long-felt desire of the people of Khulna. But no practical step was taken for this purpose. As a result, the plan is yet to be implemented and dream materialised into

In the parliamentary elec-tions of 1991 and 1996, all po

litical parties included con-struction of Rupsha bridge was their main issue in their mani-festos. But they have so far failed to show any example of sincerity in honouring their commitments.

Begum Zia as Prime Minister laid foundation stone of the bridge. At first, twenty crore taka was sanctioned to start the primary works of the con-struction. But later it was reduced to two crore taka only for constructing approach road and for miscellaneous works.

But construction of approach road was also shelved. Because, land required for construction of approach road could not be acquired due to reasons yet to be known. So, plan for 29 kilometre long approach road at Labonchora was, however, dropped.

The crux of the problem is acquiring of the land needed for approach road construction. The Ministry of Land Reforms is yet to okay the proposal acquiring the land, the source added.

Earlier the ECO prepared and published the aforementioned result violating the academic council and syndicate decision by following the previous class grading system in-stead of newly introduced class

grading system.

The 284th academic council meeting took a resolution stopping the upper second class and changed the previous 4 (four) separate class gradings into three class grades in regard of awarding honours degree.

However, the ECO did not follow the academic council decision which was later approved by university syndicate. A news item has been published in The Daily Star in this regard on July 24 last.

He then asked. how he was responsible for the fault as he just signed the sheet after the approval of vice-chancellor?

On the other hand, Prof A B Siddique, chairman of the department of law accused the ECO for the fault of publishing the result following the former class grading system Prof Siddique acknowledged that all of examination related works are normally done by teachers but ECO supplies all sorts of papers and gives logistic support.

He said that ECO had given them the old form of tabulation sheet marking the former class grade and the tabulator only filled up the blanks (with the marks) according to instruction printed on the tabulation sheet. Both ECO and DL accused

each other for the mistake. But in this regard, unfortunately, both ECO and DL failed to trace that the newly introduced system of class grading was supposed to be followed from law masters session 1992-93.
