Announcement of 5th Wage Board award demanded

Sangbadik Oikyo Andolon (SOA) yesterday called for announcement of award of the Fifth Wage Board within three months, reports BSS.

A meeting of the executive committee of SOA with its president Alauddin Ahmed in the chair said the BNP government did not announce the Dearness Allowance and award of the Fifth Wage Board during the last five years, a press release said. Later on the caretaker government declared the dearness allowances.

The formation of the Fifth Wage Board has been made by the last BNP government.

The meeting appreciated that the new government had sent letters to the owners of the newspapers to implement the dearness allowances declared by the government.

Resignation of CEC demanded

The Supreme Court unit of Bangladesh Jatiyatabadi Aijibee Forum yesterday demanded immediate resignation of the Chief Election Commissioner for his failure to maintain neutrality during the September 5 by-elections, reports UNB.

The Forum, at a meeting criticised the ruling party for capturing polling centres in Laxmipur-2 and Chittagong-1 constituencies during the by-elections.

The meeting condemned the killing of 57 leaders and workers of BNP during the last two months, said a press release.

It also protested the pro-Awami League Chhatra League bid to capture halls of different educational institutions.

Presided over by Forum president Abdur Rab Chowdhury, the meeting was addressed, among others, by Barrister Rafiqul Islam Mia, Zainul Abedin, Lutfi Alam, Humayun Kabir Bulbul and Abdur Ahad Mia.

JCD accuses BCL of violating peace accord

Jatiyatabadi Chhatra Dal (JCD), the student wing of opposition BNP yesterday alleged that the Awami League-backed Chhatra League (BCL) was violating the "peace agreement" reached among the student fronts for maintaining congenial academic atmosphere in the Dhaka University.

The allegation was made during a JCD rally in front of the DUCSU building yesterday. The rally was addressed by acting JCD president MA Khaleq DU unit president ABM Mossarrif Hossain and general secretary Monir Hossain.

The JCD leaders said that the agreement was signed with an aim to rehabilitate the bonafide students in their respective dormitories by driving out the terrorists. But the outsiders are still living in the residential halls under the protection of the Chhatra League, they alleged.

They also alleged that the BCL activists were forcing the JCD workers to leave the dormitories who were rehabilitated according to the peace accord.

They also demanded the withdrawal of cases filed against the leaders and activists of BNP and JCD which they said were false.
