### JCD accuses BCL of violating peace accord

The JCD leaders said that the agreement was signed with an aim to rehabilitate the bonafide students in their respective dormitories by driving out the terrorists. But the outsiders are still living in the residential halls under the protection of the Chhatra League they alleged.

They also alleged that the BCL activists were forcing the JCD workers to leave the dormitories who were rehabilitated according to the peace ac-

They also demanded the withdrawal of cases filed against the leaders and activists of BNP and JCD which they said were false.

cerned to set up a new power station in the city to solve the power crisis.

Local CPB leaders Muniruzzaman and Advocate Dilip Das also addressed the rally.
