

Seven licences of fire-arms cancelled

MOULVIBAZAR, Sept 21: Seven licences of fire-arms has been cancelled by the district administration of Moulvibazar recently.

According to the official source of Deputy Commissioner of Moulvibazar, these fire-arms licences were issued during the period from 1991 to early part of 1996. The source added that district Special Branch (SB) of Moulvibazar had recommended to the Home Ministry for cancellation of the said licences as there was no need of holding fire-arms by the said licence holders. There were two fire-arms against two cancelled licences which was duly recovered by the administration after cancellation order of licence.

Other five cancelled licence holders had no fire-arms against their respective licences. Of the cancelled licences, five licence holders were resident of Baralekha thana

and one each of Srimongal and Rajnagar thanas.

The source further said that, a total of 97 licence of various categories of fire-arms were issued during the period from 1991 to early part of 1996. Of these issued licences, 61 licence were issued in 1991, 20 licences in 1992, 5 licences in 1993, 8 licences in 1994, one licence in 1995 and 2 licences were issued in early part of 1996.

According to categories of issued licence during the period, 3 were issued for pistol, one for revolver, 4 for 22 BR and rest 89 for short gun.

On the other hand, only 8 weapons of various kinds and eleven round of bullets were surrendered voluntarily during 7-day period after the government announcement on August 7th. The weapons which were surrendered include 3 revolvers, and five pipe guns.

Six women take poison, 3 die in Pabna

PABNA, Sept 21: Six women from different villages of Chatmohar thana took poisonous insecticides allegedly attempting to commit suicide on September 9 and three of them died. In critical conditions three others were shifted to Chatmohar Thana Health Complex.

The three who have died are Rashida Khatun, 25, wife of Naoshad Sarker of village Koirapara; Musammil Badiol, 30, wife of Abdul Latif of Natunpara of Gunaigachha Union and Julekha Khatun, 50, widow of late Harunur Rashid of village Pashchim para under Chhaikhola Union.

Three others who were admitted into hospital after taking poison were: Farida Begum, 30, wife of Abdur Razaque; Lipi Khatun, 24, wife of Rabiul Islam of village Ramnagar and Shaheda Khatun, 20, of Fojilana.

Separate UD cases were filed with Chatmohar thana concerning three cases of death by suicide.

It has been claimed by the police that family feuds were believed to be the reasons for the cases of suicide or attempt there of.

Police further disclosed that already 32 unnatural death cases were registered in Chatmohar thana alone till September 9 starting from January this year. Most of these are also cases of suicide.

Four die as boat capsizes

KISHOREGANJ, Sept 21: Four persons including three minor girls drowned when a boat capsized in a haor of the thana Wednesday afternoon.

According to police sources, the boat carrying 10 to 12 passengers was on its way to Wara village from Kakail char in Azmirganj thana. The boat turned turtle due to the tremendous current in the haor near Wara village.

The bodies recovered were identified as Dolly, 4, Selina, 3, Yasmin, 2, and Jahanara Begum, 25. Of the victims the first two were sisters and their mother Safia Begum is reported to be still missing. The dead bodies were later handed over to their relatives, the source added.

Notorious dacoit held

KUSHTIA, Sept 21: Abdus Sobhan, a notorious dacoit, was caught by the people of Taragonia bazar on Tuesday night with the help of the night guards of the bazar. Later he was handed over to Daulatpur thana police.

Police said that accused Abdus Sobhan is a wanted criminal and has several cases registered with Daulatpur police station against him.

Police was searching him in connection with a theft case of timber which was stolen from the wood store of Jamiruddin Saha of the same village worth Taka 20 thousand recently.

The stolen timber were recovered from the house of Abdus Sobhan but he could not be arrested.

9 committed suicide in last 5 months

FARIDPUR, Sept 21: Nine person including two children committed suicide at different areas in the district during the last five months.

According to police source one Jalil Molla, 97, son of late Edhan Molla of north Alipur under Faridpur pourasava committed suicide by hanging himself from a bamboo pool on September 11. The victim hanged himself to death owing to intolerable pain in the stomach — family source said.

One Jahurul Haque Molla, 12, son of Abbas Molla of village Char Kestapur under Char Madhabdia union in sadai thana committed suicide by taking insecticide in paddy field on September 10. Family feud was the cause of the suicide — police source said.

According to police source one Tazul Fakir, 17, of village Paranpur under Kotwali thana poisoned himself to death on August 31. Pain in the stomach was the cause of his suicide — family source said.

Nepal Kumar, 20, of village Shingpara at Goalchamot area in the town committed suicide by taking poison on April 4. The victim took poison being

failed in love affair — family source said.

Joynab Bibi, 30, wife of one Sikander Mia of village Darjapuri in Nagarkanda thana poisoned herself to death on March 7. Pain in the stomach was stated to be the cause of her suicide, police source said.

Jasna Sarker, 30, wife of one Nimai Chandra Sarker of village Ananda Nagar under Kotwali thana committed suicide by taking poison after poisoning her son Nishikanta five months old to death.

Family feud was the cause behind the incident, police source said.

According to police source, Sabita, 14, daughter of Khandaker Alauddin of village Chator under Boalmari thana committed suicide by taking poison on March 23. Family source said pain in the stomach was the cause of her suicide.

Nasima Akhter, 23, wife of Anwar Hossain of village Shaal Dupi under Sadarpur thana poisoned herself to death.

Family trouble was stated to be the cause of her death. Separate cases was lodged with respective thanas in these regards.

Farmers face economic hardship

MADARIPUR, Sept 21:

Farmers of the district are facing serious economic hardships as they are forced to sell their aus and aman paddy at throw away prices in the absence of government procurement centres, reports UNB.

The farmers of the district said the paddy is being sold between Tk 189 and Tk 200 per maund which is below the production cost. But they had to buy seeds, fertilizers and insecticides at higher prices.

The marginal and share cropper farmers of Kalkini and Shibchar thanas said they are not in a position to repay bank loan and money borrowed from the local money-lenders due to sudden fall in prices of paddy.

They urged the authority concerned to immediately set up paddy purchasing centres at different thanas to enable them to sell their paddy at fair prices, kilometer from Rangamati town.

The timbers were allegedly extracted illegally from the nearby forests for smuggling, sources said.

The timbers recovered were brought to Rangamati for taking further necessary action.

Nobody was rounded up in this connection. A case was filed.

Peace accord breaks as clash erupts

SIRAJGANJ, Sept 21: The peace accord jointly signed by major political parties and student organisations in Sirajganj district could not last for even a month. On the 21st day of signing of the agreement of code of conduct JCD and BCL (S-P) clashed furiously at the premises of Sirajganj Government University College on September 18 which left 45 students injured.

Awami League, BNP, BCL (S-P) and JCD leaders in Sirajganj signed a peace accord to keep campuses of the district free from violence. On September 18 last BCL and JCD activists clashed at the college ground on the issue of beating up of a BCL worker. Arzoo allegedly by JCD workers on September 17. BCL accused JCD for violating the peace accord.

During clash massive explosion of cocktails rocked the

town. The clash also engulfed EB road and Kalibari road creating panic among the people. Police allegedly played a silent role. After about two hours clash, 45 students of both the groups were injured. Seriously injured BCL workers Nazmul, Jalil and Insaaf and JCD workers Lenin and Manna were admitted to different clinics.

Later on, BCL workers swooped on the office of the Police Super.

RU student expelled

Two guilty of smuggling

KISHOREGANJ, Sept 21: Two persons were found guilty and sentenced to suffer rigorous imprisonment on charge of smuggling.

One Kazi Awal of village Raindhanadar in Akaura Thana of Brahmanbaria district was sentenced to suffer RI for three years with a fine of Taka 5000 or in default to suffer RI for three months more while Humayun Kabir (absconding) of village Pacchim Dhamuri in Chowddhagram thana of Comilla district was sentenced to suffer RI for five years and to pay a fine of Taka 5000 or in default to suffer RI for three months more.

Md Shahidullah, Special Tribunal Judge of Kishoreganj awarded the above-mentioned punishment to the aforesaid persons while delivering a judgement on September 14.

The prosecution story in brief is that on the night of February 6, 1992, Bhairab railway police, after getting a secret information raided a compartment of Dhaka-bound inter-city Upaban train at Bhairab railway station and recovered some Indian spare-parts of motor-cars worth about Taka 50,000. Police arrested Kazi Awal and Humayun Kabir in this connection.

A case was registered with Bhairab railway police who after investigation submitted charge-sheet against them leading to the trial court of Special Tribunal Judge.

Families of Langadu victims given money for rehabilitation

LANGADU (Rangamati), Sept 21: With a view to rehabilitate the families of Langadu thana in the district affected by the tribal insurgents in Churakhali massacre on September 9, the Rangamati Hill District Local Government Council (RHDLCG) has here disbursed an amount of Taka 1.8 lakh among 37 families in an informal function as a part of its rehabilitation programme, officials said.

The dependents of the deceased families were given Taka 5,000 each while the injured and the escaped were given Taka 3,000 and 2,000 respectively.

The convenor of the Relief and Rehabilitation Committee of RHDLCG councillor Ruhul Amin alongwith councillors ASM Shahidullah and Sardar Ahmed Ali made the disbursement of money in the function attended by local elites and government officials.

Meanwhile, Shahadat Hussain, the Thana Nirbahi Officer of Langadu thana has also distributed Taka one thousand to each affected family on Thursday September 19 last as an emergency relief which will be adjusted while disbursing Taka 50,000 to each family as declared by the ministers at Langadu on September 12 last, officials said.

Housewife rescued

JHENIDAH, Sept 21: Abducted housewife Rezzmin Ara alias Alpana, 18, of village Dhakola in Sailkupa thana of the district was rescued from village Debdala of the same thana recently, police said.

Police sources said, Alpana was abducted by some young men in the night of September 16 last while she was sleeping in her house. His father filed a case with Sailkupa thana in this connection. Police rescued the victim and arrested four persons for their alleged involvement with the abduction, police said.

IU student expelled

ISLAMIC UNIVERSITY, Sept 21: The Islamic University (IU) authorities expelled a second-year student of English reportedly for making attempt on the life of a teacher on August 10, reports UNB.

IU officials said today the student, Mollah Mohammad Mohsin, was caught by some students of the department when he forced Assistant Professor Shahinur Rahman at gunpoint to give him extra marks in a test. Mohsin is now in Jhenidah jail.

The university syndicate took the decision last Tuesday upon the report filed by a three-member probe body, headed by Prof Harun-ur Rashid of the English Department. It also put permanent ban on the movement of Mohsin on the campus.

Bus passengers looted, 15 injured

JHENIDAH, Sept 21: Armed dacoits looted valuables worth Taka at least two lakh, injuring 15 passengers, from a Kushtia-bound night coach in the night of September 13 last, according to reports.

According to some passengers and eye-witnesses, some eight to nine armed dacoits who took sits from Gabtali terminal in the guise of passengers took control of the night coach near Magura at about 1.30 am on gunpoint. Then the miscreants started looting and came down near Bhadalia about 8 kilometres from Kushtia.
