

Rejoinder

In response to a rejoinder by BUET, published on page 9 of our Sunday's issue, BUET Teachers' Association has sent the following rejoinder:

It is unfortunate that the BUET authority has provided fabricated and distorted story to undermine the demand of the BUET Teachers Association.

The Teachers Association in its general meeting on Oct 12 resolved unanimously, and has since been demanding, the removal of Prof M Shahjahan as Vice Chancellor.

It is not true that meetings are held "as and when necessary" as claimed by the BUET authority, because in pursuance of a Teachers Association resolution of Oct 7 to boycott all meetings presided by the Vice Chancellor Prof M Shahjahan, the Committee of Advanced Studies and Research (CASR) meeting of Oct 8 and the Academic Council meeting of Oct were not held.

The "meeting" referred to in the rejoinder by the BUET authority was not a convened meeting, rather the representatives of the Teachers Association had gone to the Vice Chancellor to press for the release order of some teachers intending to go abroad for higher studies and research.

Stalemate in BUET indeed prevails and the situation may worsen after Oct 16 when the Teachers Association's deadline for the removal of Prof M Shahjahan as Vice Chancellor expires, after which the Association has vowed to go for a greater movement."

130 arrested
