
Bhanu Nessa — another unsung heroine

PABNA, Dec 14: Musammat Bhanu Nessa, of village

She said, "the Freedom Fighters took over Santhia thana on December 7 and Santhia was free since then. But the treacherous Pak Army again came from Pabna town to attack Santhia thana on the next day. Following a fierce battle, the Freedom Fighters (FFs) defeated the enemy forces who fled leaving one vehicle and a truck. The Freedom Fighters apprehended return of forces. So they blew off the bridge near Joregachha and ambushed nearby. As was suspected, the Pak forces again came but was halted near the damaged bridge on

the morning of December 9 and the Freedom Fighters launched a severe attack."

Bhanu Nessa further said, "the battle was continuing not very far away from my house. At one stage, the Freedom Fighters were short of cartridges and sent message to her for arranging supply of the same from Santhia Police Station which was under the command of Muktijoddhas. I requested some persons, but all refused to do the job. Then I myself rushed to Santhia Thana and approached the President of Santhia Thana Awami League late Abdul Wahab Jitu who delivered a bag of cartridges and other ammunitions. The bag was too heavy for me to carry. Anyhow I managed to carry the bag and secretly supplied the cartridges to the Freedom Fighters in their bunkers. The fighters became much inspired, they continued the grim battle till 5 pm, when after suffering huge losses, the enemy forces retreated for good. I received a bullet injury on my forehead, but I forgot the pains due to the joy of victory that

Asked what help she got from the government or from Muktijoddha Kalyan Trust so far, she said, "nothing." When asked what she wanted now, she said that she had no

demand except the welfare of the poor people.

When requested for expressing her feeling on the Silver Jubilee of the victory, she said. "I am so happy that I am alive on this historic day and I only want a happy and prosperous Bangladesh which was the dream of all the Freedom Fighters."



SYLHET. Fifteenth December is a red letter day for the people of Sylhet, the north eastern district of the country. 25 years back, on this very day in 1971, the district headquarters was freed from the clutches of the Pakistan Army.

Sylhet, the holy township with the memory of the great saint Hajrat Shahjalal (RA) was echoing with the sky-touching slogans by thousands of joyous Freedom Fighters and people from all walks of life, who entered into the town following the

fall of Pak Occupation Army.

Thousands of people of this township and suburbs tasted victory, a day before the day on which the whole country witnessed victory, that is the 16th day of December. The then Indian Government officially recognised Bangladesh on

Like many other Freedom Fighters, Khaibar Ali, 50, a valiant Freedom Fighter of Kurigram has been forced to earn his livelihood by begging from door to door.
Soon after the Liberation War fate of many people was

changed. Khaibar Ali did not see any fortune. He turned into a street beggar. During the last 25 years which elapsed after the emergence of Bangladesh nothing was provided to this poor helpless Freedom Fighter of Kurigram from the government, it is learnt.

Confronted with poverty he has been residing with his seven-member family in a worn-out house at Nowdabash in Panchgachi union under Kurigram sadar thana.

It is to be mentioned that Khaibar Ali joined the Liberation War in 1971 and fought against the occupation Pak Army in Sector No-6. At the time of operation in the war field he lost both his eyes in a bomb blast. After the Liberation War, he fell in distress. Ultimately he started begging from door to door and became a street beggar.
