4 injured inmates admitted to Khulna hospital

KHULNA, Dec 24: Four inmates of the Jessore Central Jail were admitted to the Khulna General Hospital with bullet injuries, according to hospital sources.

Of them, three are convicts and one is undertrial prisoner. They have been identified as Abdus Sattar, 45, awarded with 47 years of rigorous imprisonment (RI), Yar Ali, 35, with 8 years of RI, Jannul Islam, 28, with 10 years of RI, and Rafiqul Islam, 28, an undertrial prisoner.

Ganja cultivation in Jamalpur alarming

JAMALPUR, Dec 24: Ganja plantation in different villages of the district has increased to a great extent for the last two years.

According to the Narcotics and Liquor Control Department sources, a total of 70 cases has been filed in Jamalpur district by the Narcotics and Liquor Control Department against ganja (hemp) plant holders during the period. Fifteen persons were also arrested.

On December 12 the department recovered one truck load of ganja plants from village Batipara under Islampur thana after receiving a secret information. A team led by Narayan Kishor Bottacharya, Director of District Narcotics Control Department raided the village and recovered the plants. Fifteen separate cases have been filed.

A reliable source said that about 1,000 acres of land are under illegal ganja cultivation

In Durgada, Pannampur, Char Amkhuya, Chukaibari Bahadurabad, Dearanganj Thana, Chaugulini, Gaibandha, Golerchar, Kulkandi, Pathashi, Nowrapara and Chinnadeeli unions in, Islampur thana, Falkucha, Ghaugora, Nangla, Mahmudpur, Kulia Adra, and Goshperpara unions in Melandah thana, Charkardah, Balijuri, Sunali, Gunaritol unions in Madarganj Thana, Pigna, Mahdab, and some villages in Sharishabari Thana, Luxmipur, Ghoradap, Rashidpur unions and other parts of sadar thanas in the current seasons.

Ganja is being transported to Dhaka, Tangail, Mymensingh, Bogra, Bhabra, Rangpur, Sirajganj, Pabna, Rajshahi, Khulna, Chittagong and other parts of the country. Women and unemployed youths are used as carriers.

According to source, about four kgs of ganja is produced from a single plant and per of ganja is sold between Taka 2,500 and 3000.

The Narcotics and Liquor Control Department, have recently seized about 20 mounds of ganja plants with on a cart from Dewanganj, Islampur thana.

Illegal sale of liquor is also going on in different areas at the district town and other places.

A number of stationery and grocery shops in the town and different market areas are reportedly involved in selling liquor bottles illegally. It is learnt.

Recently a powerful task force headed by Deputy Commissioner of Jamalpur was formed to control and eliminate the ganja plantation in the district.

RAJBARI, Dec 24: A frustrated lover avenged his insult by throwing acid on the face of a teen-ager at a village in sadar thana, the girl's parents alleged, reports UNB.

They said their daughter Taslima Khatun, 14, a student of Class VII in Siddikiya Hafiza Madrasah, had been irresponsible to Masud Rana's amorous overtures.

The thana sources said, enraged by her indifference, Masud Rana collected some of his friends and broke into her room, threw acid and fled.

Taslima is undergoing treatment for burn injuries on her face in Rajbari sadar hospital. A case has been registered in sadar thana in this connection.

The O-C of Sadar thana Kamal Hossain said three people involved in the incident Shamsul Haq, Abdul Gani and Shafiqur Rahman were arrested. But the main culprit Masud Rana is absconding.

"Trained officials needed for quality admn"

SAVAR, Dec 24: Minister for Education, Science and Technology and Primary Education Division ASHK Sadique has said highly trained and educated officials are needed for the development of qualitative administration, reports UNB.

He was speaking at a function of the Bangladesh Public Administration Training Centre here recently.

The Minister said training could play an important role to upgrade the quality of administrative officials.

He also expressed his opinion that the main objective of the officers training would be to bring about a qualitative change in the administrative system.

Traffic jam causes concern

MADARIPUR, Dec 24: As implementation of the approved project for construction of the Tekerhat bus terminal remains uncertain, traffic congestion on the main road junction has started causing concern here, reports UNB.

Tekerhat in Rajor thana is considered as a gate-way to the southern districts, which is used by buses, trucks and jeeps to go to other districts including Madaripur sadar, Barisal, Dhaka, Rajshahi, Khulna, Gopalganj, Faridpur, Patuakhali and Meherpur.

In the absence of a proper bus-terminal, about 60 to 70 buses stand helter-skelter on the main road junction blocking the roads for hours together.

It is feared that traffic jam will intensify when work is taken up for construction of traffic island at a cost of Tk 32 lakh.

The Roads and Highways department of Tekerhat said the Zila Parishad has handed over three acres of land one and a half years back to build a modern bus-terminal with all passenger amenities.

But no initiative has yet been taken to construct bus stand.

One severely stabbed, killed in Bhola

BHOLA, Dec 24: A man was killed following a dispute on harvesting crops at a char village in Borhanuddin thana on Thursday, reports UNB.

Police said Fakrul Alam, 35, of Patar char was severely stabbed by some miscreants when he tried to resist them from cutting Aman paddy from his field at night. He died on the spot.

Local people caught the attackers red-handed and handed over to the police. A case was filed with the police.

Rice loaded wagon falls in river

GAIBANDHA, Dec 24: A railway wagon loaded with rice fell into the river at Bahadurabad ghat and two others turned turtle as a result of jolting of an engine on board.

Sources said, at 8 pm on December 20, a wagon tug boat No. 9 anchored at the jetty of Bahadurabad ghat. During the shifting of wagons from burge track a shunting power engine dashed the wagons after the master failed to control the power. Due to impact one wagon No. 55083 loaded with 350 bags of rice fell into the river and two other stone loaded wagons No. 52596 and 53974 turned down on the floor of burge after being derailed from on board track.
