

Loadshedding

11 jute mills incur loss over Tk 12 cr

KHULNA, Feb 2: Eleven jute mills of Khulna zone have so far incurred loss of over 12 crore taka in last six months due to continuous loadshedding. There are other factors for the loss including higher production cost, labour unrest and outstanding bills of wages of the workers and employees. Besides this, loss of reputation in quality production in world market and failure to supply jute goods as per need are also among the causes for ruining the business of golden fibre.

According to reliable source, production works in all these 11 jute mills remain suspended for over four hours on average

everyday due to loadshedding. These mills lost 3,697 metric tonnes in production in last six months. According to Bangladesh Jute Mills Corporation (BJMC) statistics, at least one thousand two hundred sixty six point ninety lakh taka were lost due to fall in production.

Production cost rose up due to loadshedding, said an official source. But wages of workers are being paid in full without day productive works, the source added.

The mills could never reach the export target from the month of July to December, 1996. Fall in export of jute

goods is also due to frequent strikes and labour unrest. The management of the mills could not pay wages properly during last six months due to anomalies in export works.

A spokesman of BJMC said despite repeated reminders to the Chief Engineer, Power Development Board (PDB), seven jute mills falling under Khulna Metropolitan City are yet to be ensured steady supply of electricity in peak hours.

BJMC demands nine megawatt of electricity to keep seven jute mills of the city running in full production works. But the PDB is still silent over this issue.

Meanwhile, Rajpara Thana police recovered a dead body of an unknown woman Thursday. Somebody took the dead body to the emergency department of Rajshahi Medical College Hospital and fled away. Police is investigating into the matter.

Boat owners resist launch services

Laying off of 3 factories in Khulna: Violence apprehended after Eid

KHULNA, Feb 2: Industrial belts of Khulna are in grip of heightening tension with the closure of Sonali Jute Mills, Bangladesh Match Factory (BMC) and Dada Match Factory. Workers and employees of these three industries are putting up road blockades, holding rallies and processions everyday demanding opening of the mills and fulfilment of their demands including payment of arrears wages.

As the situation is turning grave day by day, violence is being apprehended soon after Eid. The local administration and the management of the mills appear to be reluctant to solve the crisis. As a result, situation may go beyond the control any moment.

Meanwhile, CBA and non CBA leaders and workers and employees of all other mills and factories of Khulna zone have expressed their solidarity and unequivocal support for the strikers. Even transport workers have also supported the movement of jute mills and match factory workers.

Road barricades by Sonali Jute Mills workers on Khulna-Jessore highway are crippling economic life of the people. Sufferings of the people know no bound.

According to different reliable sources, owners of these mills and factories are heavily burdened with huge amount of bank loan. To get rid of loan repayment they are closing the mills and factories through different machinations creating big credibility gap between the workers and CBA leaders.

According to reliable sources, workers and employees of Sonali Jute Mills are yet to be paid up their outstanding wages and P F fund money. As a result, they are passing days in untold sufferings with members of their families. No fruitful result has so far been achieved despite frequent meetings and sittings with the officials of the concerned ministry.

Sonali Jute Mills was declared closed since November 16. Since then workers and employees have been agitating to press home their several demands.

On the other hand, Bangladesh Match Company (BMC) firstly closed without any reason in 1990 throwing some 985 permanent workers and employees out of job. It was re-opened in 1992 providing 417 workers with jobs. But fact remains that 27 workers and employees died reportedly from starvation and different diseases without treatment during its closure for long 27 months. The management of the match

factory again retrenched 390 workers and employees on March 6 of 1995 on the plea of financial loss. The most tragic part of the foul game of the BMC management was that reinstated workers and employees were compelled to agree with the proposal for accepting half of their salaries. Besides, they were paid their gratuity for thirty days instead of sixty days. Yet, the management closed down the factory on and from September 1 of 1996 in violation of all relevant rules and regulations of labour law.

Highway dacoity : Property worth Tk 2 lakh looted

HOBIGANJ, Feb 2: A gang of dacoits on Dhaka-Sylhet highway looted property worth about Tk two lakh from the passengers of a Sylhet-bound mini-bus in Bahubal thana of the district, reports UNB.

According to passengers, four dacoits got on the mini-bus in disguise when the bus from the capital reached at Mirpur on the highway.

Later, the armed muggers took over the control of the bus at Kamaichalia in Bahubal thana, attacking the driver with a sharp weapon.

They decamped with the booties, including ornaments, wrist watches, a DD of Tk one lakh and some cash from the passengers of the bus at gunpoint.

The driver was rushed to Srimangal thana health complex with injuries. Local SP admitted the incident of dacoity.
