DU Philosophy deptt platinum jubilee programme opens President stresses need for taking lessons from philosophy

President Justice Shahabuddin Ahmed has said "we must be conscious about our national objectives and ideals" to find a place of honour and dignity in the comity of nations, reports UNB.

"None wants the crisis — economic as well as humanitarian — that Bangladesh is now facing," he told a reunion of former students on the Dhaka University campus yesterday.

He, however, stressed the need for taking lessons from

philosophy which plays a significant role in building a good life and society as well.

The President, who is also the Chancellor of the university, was addressing as chief guest at the inaugural function, organised by the Philosophy Department, celebrating its Platinum Jubilee.

National Professor Dewan Muhammad Azfar, the senior-most former student of the department, also addressed the function, attended by DU Vice-

Chancellor Prof A K Azad Chowdhury as special guest.

President Shahabuddin said an extreme despair is now prevailing in the society due to hunger, poverty, unemployment and all those which essentially result in various crimes.

He pointed out, "Today's mankind is living in a world, where there is widespread restlessness and unhappiness despite unprecedented progress in science and technology."
