

— Metropolitan — Govt to recruit 1000 more doctors: Yusuf

Some 1,000 doctors will be recruited by the government soon to expand medicare service for the people, the Health Minister said yesterday, reports

"We will also take step to appoint one MBBS doctor in each union in phases to ensure healthcare facility for the rural people," said Salahuddin Yusuf.

The Health and Family Welfare Minister was speaking as chief guest at the two-day 5th national convention and scientific seminar of Bangladesh Society of Radiology and Imaging in the city yesterday.

He told the function that the present government had created 3,119 new posts under the Health Ministry, and more than 100 of them had been kept for radiologists.

Radiologists will be appointed in each district head-

quarters and arrangement made in the future for providing ultrasonogram machine to every district hospital, Yusuf said. He said "health for all" should be ensured to achieve economic development, and so the government had already taken many steps to that end,

including budget increase for

health sector. Salahuddin Yusuf said the government has set up most. modern MRI machine at PG Hospital so that the patients do not have to go abroad for better

treatment. Efforts will also be made to procure more such machines. Necessary measures have also been taken to set up CT scan machines at medical

college hospitals, he added. The minister said measures would also be taken so that each thana would have an X-ray machine, adding that X-ray machines have already been sent to some thanas. Skilled staff, radiologists and radiographers will be appointed there.

Later, the minister gave away the 'Radiologist of the Year' award to Prof A S Q Mohammad Sadeque.
