3 killed in truck accident

When it was crossing Mokamtola suddenly the truck skidded off the road and turned turtle into the road side ditch.

One Aziz, 40, died on the spot and five others, including the driver were removed to Bogra Mohammed Ali Hospital with critical injuries. Sono Diagnostic Centre: A boon for arsenic victims

KUSHTIA. Mar 16: Dr A H Khan, Prof of Chemistry, Dhaka University and former Director, Atomic Energy Commission and a renowned scientist of Bangladesh in a press conference held recently at the local Sono Diagnostic Centre said that detection of the presence of arsenic in tubewell water and its way of removal by scientific method can prevent attack of arsenic in the body of a person.

He was giving answers to the questions of the local journalist at the centre. In reply to questions he said that arsenic enters into the body through air, food, water and physical state of arsenic is 3 and 50. Number 3 is harmful, it consumed oxygen and oxygen intake is reduced, effect of arsenic appears in the body. But it may go out within 10 hours to 10 days. He also described many methods to remove arsenic.

Regarding setting up of com-putarised Electro Chemistry method at Sono Diagonistic Centre be said that this instrument can detect the ratio of arsenic in water in a most modern method. It also can measure the quantity of arsenic in a body by examining hair, nail and flesh of the body.

he also congratulated Dr Monir who has established this instrument in his diagnostic centre, only one such in the country by private sector and expressed his hope that this will help immensely benefit the people of this region particu-larly Khulna and Rajshahi di-

tion, four alleged accused persons were caught red-handed by the police patrol party near the bridge of Jagla on Magura-Jessore via Arpara road on April 20, 1996 night while attempting to commit dacoity with arms. The police recovered shuttergun with bullets.

The court found another two alleged accused not guilty and acquitted them of the charge.
