

Authorities' negligence cripples mental hospital

PABNA, Mar 17: The lone mental hospital of the country here has been suffering from so much neglect as to make it unable to render service to the increased number of patients according to social leaders and sources in the hospital management, reports UNB.

Inadequate number of beds, insufficient budget, shortage of doctors and technical personnel, lack of maintenance and amenities have been crippling the mental hospital for the past several years, they said.

The number of beds was not increased in the last 30 years although a high power committee recommended its upgradation to 500-bed hospital in 1986.

The hospital started operation in the 'Shitali House' in Pabna town with 60 beds in 1957. It was shifted to present site on the bank of the river Padma, three km away from the town and upgraded to 200-bed in 1959 and 400-bed in 1966.

There are 120 paying beds, 40 reserve beds for the chronic patients and 240 general beds in the hospital, which are too inadequate for the heavy demand.

On an average, three hundred patients come to the outdoor of the hospital daily, but the hospital can not cope with the rush due to shortage of doctors, other staff and requisite amenities.

Out of 18 wards of the hospital, four wards — Child Psychiatry, Geriatrics Psychiatry, Mental Sub-normality and Community Psychiatry lack experienced and trained doctors and staff.

Besides, considerable shortage of man-power, the few doctors and the other staff of the hospital are reluctant to stay near the premises for lack of civic facilities and amenities in the neighbourhood as the hospital is situated far away from the Pabna town.

Erratic power supply due to loadshedding, sub-standard diet are other problems.

Two killed in road mishap

Of them condition of Shaju Mia, Abdul Jalil, Parveen were stated to be critical and removed to Rangpur Medical College Hospital.

A case was filed with concerned thana.

The bus driver, however, managed to flee.

Abduction, robbery frequent in Kushtia

Sharp rise in crime rate

KUSHTIA, Mar 17: Law and order in Kushtia district particularly in Daulatpur thana is now beyond control. Terrorists reign the areas day and night committing various crimes.

On Thursday night they set ablaze houses of one Esar Ali when he failed to pay ransom money for release of his son, Nayeab Ali who was abducted by them a few days back. Daughter of Esar Ali was burnt alive in the fire which could not be extinguished. All his belongings including cattle heads were burnt to ashes.

The role of law enforcing agencies is reported to be negligible in this respect. Meanwhile, law and order of Daulatpur thana was reviewed in a coordination committee meeting held at Daulatpur thana parishad auditorium with Razaul Huq, Chairman Hogobaria union parishad in chair on February 20. All the union parishad chairmen attended the meeting and alleged that reign of terror has been let loose in remote villages of the thana where robbery, theft, dacoity, kidnapping, murder, toll collection, clash between rival groups have increased to the utter dismay of the residents and peace loving people of Daulatpur thana. In the meeting the chairmen have alleged that police administration have completely failed to contain all these crimes and said that some of the villagers of Pearpur, Aira, Khalisakundi, Boalia, Refayetpur, Daulatpur, Hogobaria are leaving the villages in fear of terrorist attack.

Every night dacoities are being committed in houses one after another and kidnapping of the inmates and subsequent demand for ransom have become rampant.

A chairman alleged that Hosenabad, Philipnagar road, Taragonia, Maricha road, Sonakundi, Balirdiar road have become the points of mugging. The chairmen demanded immediate steps to be taken by the administration to stop all those crimes and to bring the culprits to books.

The Daulatpur Thana Nirbahi Officer who was present in the meeting has assured them of taking appropriate steps in bringing those to the notice of the higher authorities in this respect. In spite of that there has been a drastic fall in law and order in Kushtia specially in Daulatpur, Mirpur and Kumarkhali thanas in spite of police raids for recovery of illegal arms and arrest of criminals.

Meanwhile two persons have reportedly been kidnapped at gun point in Daulatpur thana on March 11. The abducted persons are Rajab Ali, 17 and Jahangir, 18.

Meanwhile two rival groups clashed near Jagati Railway Station on March 11 night and a vehicle was damaged by the terrorists. One group demanded subscription from a driver of the vehicle and when the driver failed to pay subscription they damaged the vehicle. On the other hand miscreants are giving threat of life in support of their demand to withdraw cases filed against them in Daulatpur police station.

Illegal gratification business

KHULNA, Mar 17: Members belonging to Mongla Dock Labourers' Management Board are allegedly realising 'Bakhshish' (reward) from stevedores through different machinations including threat of strike.

As a result, the stevedores are being compelled to pay about ten crore taka every year in the name of 'Bakhshish' which in other sense of the term is illegal gratification.

The illegal gratification is demanded by the workers when cargo handling operation begins. They blackmail the stevedores threatening strike till money is paid in full. A spokesman of the Dock Labour Management Board alleged that workers do not start work until and unless the amount of reward (illegal gratification) is declared.

According to Port Users' Association, dock labourers stop work if so-called, reward is not paid well in advance as per demand. Works in the ships begin only when the matter of reward is settled.

Stevedores have to pay over two lakh and fifty thousand taka every day per ship as reward, it was learnt. They have to pay 'Bakhshish' even to employees concerned with handling operation department of the port. Over four hundred foreign ships call at the port every year to load and unload exportable and imported goods.

It may be mentioned here that Mongla Port Dock Labour Management Board was established in 1987.

Meanwhile, all sorts of operations at the country's second biggest Mongla Port are virtually on verge of closure due to increasing siltation problem, non-lifting of sunken ships, frequent labour unrest, deep-rooted corruption in the port authority administration.

According to knowledgeable sources, if situation continues like this, the port will cease to exist in the true sense of the term by the year two thousand.

According to a competent source, heavy siltation is threatening navigability of Mongla Port. As a result, foreign ships have to fully depend on high-tide for arrival and departure.

Besides, the sunken ships at the Passur channel are yet to be salvaged. The sunken ships posing serious threat for operational works.

Kidnapped BCL leader released

JHENIDAH, Mar 17: Kidnapped BCL leader, Matiar Rahman Mati, was released after 10 hours of kidnapping on Saturday morning, according to police sources.

Police said, Mati, 28, president of Bangladesh Chhatra League Kaliganj thana unit in Jhenidah district was abducted by a gang of armedmen at about 10.30 am on March 15 near Bishoikhali bazar.

Later, he was released at about 8.30 pm near Kaliganj in Jhenidah district.

Two including girl commit suicide

KISHOREGANJ, Mar 17: A young girl and an old man committed suicide in Kishoreganj district recently.

Police sources said, Rima Akhtar, 15, daughter of Abdul Zohar of village Bara Azaladi in Pakundia thana swallowed poison for unknown reason recently. She was immediately admitted into Pakundia Health Complex where she breathed her last. The relatives who attended the patient fled the scene immediately after her death. She was suffering from mental disorder, police said quoting the villagers.

Untoward incidents, free movement of terrorists carrying lethal weapons, murder in broad day light even in the premises of Kushtia collectorate compound, stabbing, raping, hijacking, illegal toll collection, abduction continuous violence, dacoity with murder, looting, grabbing of properties, issuing letters demanding subscription with threat have become common feature during last 3 months.

Two murders were committed on March 10 and 11 in the hands of armed miscreants. Md Dabhol, 28, of village Bhabanipur while in work in his fertiliser shop at 10 pm a number of armed masked miscreants came and demanded subscription of Taka one lakh. On his refusal they dragged him from his shop and took him to nearby field and shot him dead.

Yet in another incident a group of armed dacoits entered into the house of one Azizul Huq of village Shashidharpur under Daulatpur thana and attacked the house owner when he rested. He was injured received severe wounds and later died on the spot. His son, Saiful Islam was also injured.

On the same night dacoits attacked the house of Shariful Islam and tried to break open the grills of windows and blasted bombs injuring Shariful Islam, 40. Cases have been registered with respective police station.

One person was killed and 20 others were injured when dacoits opened fire in village Bhairachar of Bheramara thana on March 11. Dacoits attacked the house of Bishu who resisted. One Shaiful, 20, was injured by bullet and was killed on the spot on the same day. Others who received bullet wounds have been admitted in Kushtia general hospital.

Tender with Bank Draft/Pay Order from any non-scheduled bank or finance company will be treated as cancelled outright.
- C) Tenderer should submit rate in percentage. The rate quoted should be written in words & figures. Only the rate written in words will be considered. There should not be any erasing/overwriting in rate writing and tender with erased/overwritten rate will be treated as cancelled forthwith.
- D) Tender with rate more than 5 (five) per cent below will be treated as cancelled outright.
