The enquiry committee also found a deposit of only Tk 145.24 crore in the share money deposit account of Shine Pukur, which should show recepit of Tk 250 crore as the shares were issued against cash payment and on full subscription.

"It appears that the management of the company has a tendency to deviate more from rules/regulations/procedures than to follow it strictly," said the committee which also held meeting with Beximco's Deputy

Chairman Salman F Rahman. Over 60 per cent of the Beximco Pharma shares were transacted by Imtivaz Hussain. Premium Securities, SES and Hemayet Uddin.

It has been observed that HMMS sold 1,101,000 shares through foreign DVP which could not be traced directly in DSE record. Similarly. Securities Consultants Limited sold 171,450 shares that also could not be traced directly in the DSE record.

As per foreign DVP statement submitted by the Bank Indosuez and Standard Chartered Bank, Imtiyaz Hussain sold 3.015,510 shares whereas as per DSE record total shares sold by him was 2,926,785 only.

Again as per bank statement, M/S SES sold 1.398,800 shares but as per DSE record it

was 908,200. Reviewing the available records, the committee found that the Chittagong Cement Clinker and Grinding Company has 12,90,000 shares at the face value of Taka 100 each which went up to Taka 134 in book

The highest market price of the share was Taka 18,048 during the peak period and there was no transaction of this issue in the bourse for more than two months. The present market of

this share is around Taka 1,731 The report said though the committee could not get into detailed examination in absence of records, supposed to be maintained by the company, it appeared that two DSE mem-

bers/brokers, Rakibur Rahman and A S Shahidul Huque Bulbul are directors of the company. Despite SEC directives to va-

cate the position, these two per-

sons continued to remain as directors, the report said.

The committee said that the SEC inquired about the sale of shares by the company to outsiders bypassing the DSE and CSE but "there was no satisfac-

tory reply from the company." The committee said that during the peak period, there were some "price sensitive announcements."

One of the directors of the company is said to have transferred a large number of shares during the July-November period of 1996 to one of their relations which were sold in the

During this period some shares were sold by foreign investors. On scrutiny it appeared to the committee that in foreign fund account an amount of Taka 282 crore for 2240 shares remained unsettled for long.

"These clearly indicates an act of manipulation. These dealings come within mischief under Section 17 of the Securities and Exchange Ordinance, 1969," the committee observed.

Beximco Pharmaceuticals Ltd, is a company of Beximco Group with 2.95 crore shares of Taka 10 each. Book value per share as per DSE statement is Taka 29.00, the report said adding the market price was Taka 67 on June 30 last year and the highest price was Taka 551 on November 16 the same

The committee report said that originally the face value of the share was Taka 100. But the company offered right shares 1:1 in 1994 with a premium of Taka 1100. The premium was over-calculated, the reports ob-

From Page 1 the team did not find any evidence of any 'electric short circuit,' which was claimed by the Assistant Export Officer of the company in his general diary field with the Narayangani thana following the fire.

The source also disclosed that so far their findings indicated that the fire was an act of sabotage. "But we will have to wait until the completion of the probe to determine the cause, he said.

Meanwhile, the CID yesterday seized several documents from the company including purchase register, stock register, two personal letters written to the company from Lalmonirhat and Baushia and a list of all the employees of the company.

Moreover, a source in the company said that at least two contradictory statements were made while claiming the damage caused by the fire which is still raging three days after it broke out. "In his general diary with the police, the Assistant Export Officer of the company put the amount of the damage at Tk 17.55 crore. But the manager

of the company, in his statement put it at Tk 13 crore." the

source said. Fire Brigade sources said that it would take another two to three days to completely extinguish the fire. "Only then we will be able to determine the extent of the damage," said an official.

The company owned a total of 28 jute godowns, of which nine were gutted. The godowns were insured with four companies including People's Insurance Company, of which, the Managing Director of Popular Jute Company himself is one of the Director.

It was learnt from other sources in the company that the godowns did not have any firefighting equipment in the premises. "There was no fire extinguisher in the godowns," said an employee of the company.

Others talking to this correspondent said that they had seen a white microbus near the godown on the day of the fire. When asked, Narayanganj police said that they did not know

He said "Generally, we have named the chairmen, vicechairmen, managing directors of the companies which have been named in the probe report and those directors whose names were specifically mentioned in the report.

The four-member enquiry committee, headed by Prof Amirul Islam, Vice-Chancellor of Jahangirnagar University, scoured the share market since it was constituted on December 27, and came up with recommendations of measures against the accused on March

"The inevitable happened, the bullish market crashed. Large number of less sophisticated and new investors suffered. Allegations of rampant manipulations were also voiced by the media and also believed by the investors. It is not easy to detect manipulative activities. Even then the committee in the short time has been able to detect manipulations and identify the wrong doers so far possible. These manipulators must be brought to task in the interest of long-term growth and development of the securities," the 81-page report observed.

BSS adds: Dr Haroonur Rashid. Chairman of the SEC. said "The commission would seek maximum punishment for those responsible for the happenings in the country's stock market. The Securities and Exchange Commission Ordinance. 1969, provides for maximum punishment of five-year jail term or fine of Taka five lakh

or both." Dr Rashid hoped that the government's action against the companies and brokers/dealers responsible for the fraudulent acts would restore the confidence of investors and help maintain normal trend and stability in the share market. The government's action would also help stop fraudulence and manipulations in the stock market and all concerned quarters would be more careful in share transactions. Replying to a question, Dr Rashid said "The enquiry committee report, in addition to identifying the fraudulent acts, also made some

UN members. The NAM meet is also likely to propose strengthening of the UN General Assembly. It would suggest that the organisation be streamlined and mechanisms be adopted to make the General

Assembly resolutions more binding in nature. NAM countries are likely to suggest expansion of the 15member UN Security Council.

members and 10 non-permanent rotating members.


The NAM's contention on expansion of Security Council is supported by the recently expressed views of the current President of the General Assembly, Razali Ismail, from Malaysia. He has called for expansion of the Security Council both in terms of permanent members and non-permanent members.

The Security Council had 11 members when the total UN membership was 51. The Council membership was increased to 15 in 1965 when membership of the UN rose to around 100 countries. Now the number of countries represented in the UN

is 185. The UNGA President has suggested that five more permanent members representing one developing country each from Africa, Asia. Latin America and the Caribbean and two industrialised states be included.

Razali Ismail has also proposed inclusion of four nonpermanent members in the Security Council from different regions.
