

Nat'l HR commission to be set up

A national human rights commission is expected to be formed in the country, reports UNB.

Law and Parliamentary Affairs Minister Advocate Abdul Matin Kahrur said this while he was addressing a discussion and an award giving ceremony at Jatiya Press Club auditorium in the city yesterday.

The minister also sought opinion from all strata of the society in this regard, highlighting the role of the state and civil society to ensure human

rights.

"Such a commission would help guide the government in protecting human rights in the country," the Law Minister observed.

Jatiya Manobadhikar Sangbadik Sangstha (JMSS) organised the discussion on "Role of State and Civil Society in Resisting Violation of Human Rights".

Dr Mizanur Rahman of Dhaka University Law Department presented a paper at the discussion programme with JMSS chief patron Lt Col (ret'd)

Zillur Rahman in the chair.

The discussion was followed by distribution of awards among some prominent personalities for their outstanding performance in their respective fields.

BMPMA president dies after speech at installation ceremony

Dr Ashiqul Alam, president of Bangladesh Private Medical Practitioners Association (BPMPA), died of cardiac arrest shortly after the installation ceremony of its newly elected executive committee yesterday.

Dr Alam suffered massive heart attack 2-3 minutes after he delivered his presidential speech at the function at the NIPSON auditorium in the city at about 12:30 pm.

State Minister for Health and Family Welfare Dr M Amanullah, who was a special guest at the function, instantly took him to National Institute of Cardiovascular Disease, where attending doctors declared him dead.

Dr Alam, a former general secretary of Dhaka Medical College Students Union, and owner of the city's Anirban Nursing Home, left behind his wife, one daughter, eight brothers, four sisters and a host of relatives and well-wishers.

Speaker Humayun Rasheed Chowdhury, BPMPA Secretary General Dr Moniruzzaman Bhuiyan and other members of its executive committee, President of Bangladesh Private Clinic Association Prof Syeda Firoza Begum, former BMA Secretary General Dr Mostafa Jalal Mohiuddin, and Vice President of SAARC Family Physicians Association Dr CM Dilwar Rana in separate statements expressed deep shock at the death of Dr Alam.

They prayed for salvation of the departed soul and conveyed sympathy to the bereaved family members.

Obituary

Nurul Hoque, a senior mechanic of Bangladesh Sangbad Sangstha (BSS), died of cancer Thursday at his village home at Panthana of Tongbari under Munshiganj district. He was 48, reports BSS.

He was buried at his family graveyard Thursday night.

Hoque was suffering from liver and lung infections for a long time.

He left behind his wife, a son, four daughters and a host of relatives, admirers to mourn his death. The *qulkhwani* of Nurul Hoque will be held on Monday at his village home after Zohr prayers.
