Tender with necessary papers & Pay Order /Bank Draft of earnest money as per rules & regulations described in the plot allotment application form & prospectus under sealed cover should be deposited in the tender box kept at the office of the Property /Financial Manager, Dhaka City Infrastructure Development Project, Housing Directorate, Section-2, Mirpur, Dhaka-1216 on 29-4-97 within 10:00 AM to 12:00 Noon. No tender will be received after expiry of the prescribed time limit. Tenders will be opened on the same day at 2:00 PM in presence (if any) of the tenders. If the necessary papers, submitted as per description of the tender, are found to be incomplete & fake, the tender will be rejected by the authority.

In view of allotting commercial plot some special information are given below for the applicants:

- One tender has been retained valid from among those submitted on 24-2-97 for the commercial plots. If the respective tenderer wants to resubmit tender for the plot in view of the present notice, he has to collect the prospectus afresh & submit tender afresh. If, in that case, additional value is quoted, then 10 per cent of the same must be deposited with the tender in Pay Order/Bank Draft under the prescribed head.
- Rate of land will be decided as per the plot area in auction through tender under sealed cover. Govt prescribed price of land has been fixed at minimum Tk 11,219.15 per sq metre. Tender submitted at rate less than Taka one crore fifty lakh per bigha, that is, 1337 sq. metre area of land will not be acceptable. The desired rate should be quoted per sq metre in the tender.
- 10% of the tender quoted value should be deposited as earnest money through Pay Order/Bank Draft from any scheduled bank enlisted with Bangladesh Bank in favour of "Executive Engineer, Dhaka Housing Directorate-1, Mirpur, Dhaka" and the original copy of the Pay Order/Bank Draft must be attached with the tender form to be submitted, otherwise the tender will be treated as cancelled. Selected tenderer shall have to pay the total value of the allotted plot adjusting with the earnest money within 60 (sixty) days of issuing allotment letter. Earnest money of the tenderers failing to receive allotment of plots will be refunded against their application within 1 (one) month from the date of the final settlement of plot allotment. But no interest will be paid.
- The allotted plot cannot be used in any purpose other than commercial. Construction work should be started within 2 (two) years of executing the Deed of Lease and foundation for minimum 5 (five) storied building should be laid.
- One applicant/firm cannot submit tender for more than one plot. In case any tenderer has already obtained commercial plot within 30 km radius of Dhaka General Post Office (GPO) in self, wife or son/daughter, father/ mother or ward's name from Housing Directorate, RAJUK or any other govt, semi-govt or autonomous organisation, or owner of any commercial plot by birth or inheritance (singly or jointly), he cannot submit the tender.
- Tender should be submitted with the layout plan attached with the prospectus marking the number of the desired plot with colour in the layout plan.

- One tenderer may submit tender for one or more centres in the same schedule for the quantities mentioned against each supply centre. Each tenderer should submit 3 (three) samples of oil each weighing half kg=500 (five hundred) grams.
- 1% (one percent) of the quoted price as earnest money should be submitted with the tender through Bank Draft/Pay-Order/Bank Guarantee from any scheduled bank of Bangladesh in favour of the Director General, Food at the time of submitting tender. Earnest money of the successful tenderer will be refunded after signing of contract on submission of performance guarantee at the rate 5% of quoted amount from any scheduled bank in Bangladesh. Earnest money of unsuccessful tenderers will be refunded after conclusion of tender programme & decision of tender committee.

- Refined edible soybean oil as per the govt. specification stated in the respective schedule of any source local or foreign will be acceptable.

- The authority may reduce/increase the quantity of precribed soybean oil to be purchased, if required.
- The contracted tenderers must complete supply of the total contracted quantity of oil within 6 (six) weeks from the date of executing the contract. But supply of 50% of the contracted quantity of oil must be ensured within 3 (three) weeks (after signing of contract).
