9 more die of diarrhoea

**Tk 47cr worth of relief goods for cyclone victims**

Relief materials, in cash and kind, worth Tk 47,46,98,730 has so far been distributed or sanctioned among the cyclone affected people of coastal districts, reports BSS.

Sources at the disaster control coordination and relief activities monitoring cell at the Prime Minister's office said Tuesday night that out of the total amount, Tk 4,74,10,750 was allocated from the Prime Minister's Relief Fund while Tk 42,72,87,980 was sanctioned from the Disaster Management and Relief Ministry. Meanwhile, nine more persons died of diarrhoea in the cyclone affected areas over the last 24 hours, raising the death toll due to diarrhoeal diseases to 39.

The nine deaths were reported from Noakhali, six, Luxmpur-2 and Chittagong-one.

According to the monitoring

cell, a total of 7133 people have been affected by diarrhoea in the cyclone battered areas of coastal districts. The district-wise break-up of the diarrhoea patients are: Noakhali 3,391, Chittagong 2220, Cox's Bazar 990, Luxmpur 428 and Bhola 104.

**DU Journalism Deptt team leaves for Ctg to distribute relief**

A 15-member relief team of Dhaka University Journalism Department, led by Dr Golam Rahman, left for Chittagong yesterday to distribute relief materials among the cyclone-affected people, reports UNB.

The relief goods include a truck load of old clothes, 15 bags of rice, 200 hurricanes, oral saline, matches, medicine and water purification tablets, worth about Tk 25,000.


