Modernisation of judicial infrastructure

World Bank to provide Tk 200cr

Law Minister Abdul Matin Khasru yesterday said cumbersome judicial procedure would be removed by updating the laws to meet the demand of time, reports UNB.

"Reforming the age-old laws is a must with the evolution of time," he said, adding the government is trying to make a law infrastructure keeping the need of next 200 years in mind.

Inaugurating a training course for subordinate judges the minister further said industrial laws would be updated for facilitating foreign investment in the country.

Law reforms recommended by the permanent Law Commission will increase foreign investment, he hoped.
