Conference told  
**Heart ailment raises five times since '75**

Some 36 lakh people are suffering from heart diseases in the country as Health Minister Salahuddin Yusuf yesterday urged the cardiology specialists to train young doctors to deal with the increasing trend of heart ailment, reports UNB.

Ischemic heart disease is increasing everyday due to rapid changes in socio-economic condition, pollution in environment and ecological imbalance, he said inaugurating the First International Conference on Cardiovascular Diseases at Sonargaon Hotel in the morning.

The conference was told that the heart ailment in Bangladesh has increased five times since 1975.

Sponsored by National Institute of Cardiovascular Diseases (NICVD), the conference was attended by about 15 heart specialists from India, Pakistan, United Kingdom and Poland.

State Minister for Health and Family Welfare Prof M Amanullah, Director of NICVD Prof M Akteruzzaman, Prof M Jalaluddin and Prof SR Khan addressed the opening session.

Narrating the grim situation in hospitals, the Health Minister said he had visited a number of 200-bed hospitals but "found no cardiovascular and monitoring units there."

He said the health network has been destroyed due to negligence and mismanagement in last 21 years.

Yusuf said the government of Prime Minister Sheikh Hasina has given special emphasis on improved treatment of heart patients.
