

# Necessary steps taken to lure FDI: PM

# Proposals worth \$1200m under process to set up power plants in pvt sector

Prime Minister Sheikh Hasina said in parliament yesterday that the government has taken a number steps to attract significant amount of foreign direct investment, which have started to deliver, reports UNB.

Replying to Harunar Rashid Khan Monno (BNP-Manikganj), she said investment proposals worth an estimated 1200 million US dollars are now under process to set up power plants in the private sector.

Of the amount, the final agreements to set up four bargemounted power plants with a total of 400 million dollar in foreign investment are expected to be signed by July this year.

She said the country has been divided into 23 blocks to explore gas and oil under production-sharing contracts, and accords have already been signed for eight blocks. Eight

more blocks are now on offer. The prime minister said already two companies have started their exploratory activities and they would invest a total of 265 million US dollars. The companies have already invested about 75 million dollars for the purpose.

Hasina said her government has taken the following steps to attract foreign direct investment and to strengthen the private sector:

- Tax holiday for five to seven years — 10 years for the units in the export processing zones. The tax holiday for power generation will be 15

- 7.5 per cent import duty on machinery and spares. No import duty on machinery for 100 per cent export-oriented indus-

profit, invested capital, royalty, technical fee, etc by the foreign investors:

- 100 per cent foreign investment allowed: - Avoiding double taxation

- Announcement of Private Power Generation Policy to allow private sector in the power

and legal system uptodate; - Formation of Administration Reforms Commission to make the administration dy-

namic; Advertisements in largely circulated foreign newspapers informing the advantages of investment in Bangladesh;

Besides, the prime minister said, seminars were arranged in different countries and she herself invited the foreign investors attending these seminars to put their money in Bangladesh.

Hasina said she would attend two seminars during her ensuing visit to Japan.

# Urea fertiliser being sold at different prices

ficial of the Bangladesh Chemi-Fertiliser dealers are selling urea at different rates because of varying prices at mill-gate

and buffer stock levels. The mill-gate price of a 50 kg bag urea is Tk 240 while its price at the buffer stocks is Tk 278, which is Tk 38 higher, Bangladesh Fertiliser Associa-

tion sources said. BFA Executive Secretary Abdul Baten said due to price of urea in the buffer stock dealers were compelled to sell it at higher prices which farmers resented. The matter turned worse as some dealers obtained urea from the mills and were able to sell it at lower prices. Baten

pointed out.

When contacted, a senior of-

cal Industries Corporation (BCIC), a government body that runs six urea factories admitted the fact.

He said due to transport costs stock price of urea was above the mill-gate price. But dealers alleged BCIC's

carrying costs were much higher than that of dealers. Urea is being sold at between Tk 250 to Tk 300 in the different areas of the country, Baten

About 24 lakh metric tonnes of urea will be required during 1997-98 financial year of which about four lakh tonnes may be imported, according to BCIĆ.

# **Show Cause Notice**

#### Show Cause Notice vide Section 43(1A) of Bangladesh Agriculture Research Council Employees Service Rules

Whereas, you Mr Pradeep Ranjan Kar, Senior Scientific Officer (Crop), BARC, son of late Atul Krishna Kar, Vill Hasamdia, PO Surjadia, PS Boalmari, Dist Faridpur have been accused of committing offence described under Section 39(C) of Bangladesh Agriculture Research Council Employees, Service Rules 1989, therefore you are instructed to show cause in writing and also state whether shall make a personal hearing by attending, within 15 (fifteen) days of publication of this notice.

#### Accusation

Whereas, you Mr Pradeep Ranjan Kar, Senior Scientific Officer (Crop), BARC went to USA for study under 2 years duration higher education (Masters' Programme) from 24.9.93 to 23.9.95 and despite compulsion to join duty, after completion of the course, on 24.9.95, you did not join duty but applied for extension of leave for further 2 years from 24.9.95 to 23.9.97. In respect of your application you were informed by letter issued vide this Council's Memo No. even dated 1.2.96 to your USA address that the extraordinary leave along with study leave with full or half or without pay under no circumstances being more than two years as per Section 26(1, 2 & 3) of Council Employees' Service Rules, admission of any additional leave could not be possible and instructed to immediately join duty. But as you did not join duty returning to country, you were again informed vide Memo No. even dated 1.1.97 by registered post to your USA address that office work was severely hampered due to your absence and you were instructed to join duty within 15 (fifteen) days of issuing the memo. But as you did not join duty and again applied for extension of leave on 4.2.97, your application for leave extension was sent to the Ministry of Agriculture for consideration. The Ministry of Agriculture, vide their letter dated 4.12.96, rejected your application and instructed to join place of work and on defy to take punitive action, thus "Notice to join work" was issued vide the Council's Memo No. even dated 29.3.97 instructing you to join duty within 15 (fifteen) days of issuing the notice with satisfactory explanation as to why legal punitive action would not be taken against you for being absent from office without permission of the authority and as such hampering office work, otherwise punitive action as per sub-Section 39(C) of Council Employees Service Rules 1989 would be taken and you were sent copies of the "Notice to join work" to your permanent address and foreign residence address (USA). But you did not join work in time or absconding without any communication with the council. Your such absconding and unauthorised absence is hampering the work of the council and your such conduct is detrimental to the above rules of the council.



# HK's role as main econ centre being eroded

HONG KONG, June 24: Hong Kong is doomed to loose its competitiveness as Shanghai emerges as the world's leading economic centre over the next 25 years, a prominent investment advisor warned yesterday, reports AFP.

Marc Faber, a Swiss fund manager renowned for his gloomy forecasts here, told a seminar that "global financial asset mania and handover euphoria" were creating an " artificial boom" in the territory.

At the same time, accelerating growth in Shanghai and other northern Chinese cities such as Tianjin and Dalian has been eroding Hong Kong's hegemony as a trading centre.

By 2005 the territorys' re-exports will have slumped, with the Shanghai stock market surpassing the Hong Kong market in size and most international companies in Hong Kong moving their head offices to the coastal city.

"A vicious secular global financial asset bear market and a property market collapse (will) create havoc for the Hong Kong economy," Faber said adding foreigners would be blamed for the problems, with many choosing to leave in such a "hostile" environment.

By 2010, the territory will be just another Chinese city,' with antique shops selling

Hong Kong bank notes and books on the local constitution. Shanghai will meanwhile resume its role as Asia's most important city after Tokyo and Osaka, with local property prices exceeding those in Hong Kong by 50 per cent. By this stage, air and maritime traffic in Shanghai is also likely to exceed that in Hong Kong, Faber

By 2020, a major political shift in China is likely to lead to a new government in Beijing. with a well-run legal and commercial infrastructure replacing the current system of personal connections and allowing Shanghai to emerge as the world top economic and financial centre, he added.

"The old guard and their Hong Kong cronies, who abused the system have been purged. For facilitating all types of practices, Hong Kong was punished - it lost all of her autonomy and heavy 'pro-patira' taxes were levied on its people,' Faber predicted.

# Business briefs

JAKARTA, June 24: A deal for Indonesia to buy Russian jet fighters could be clinched in early July when a Cabinet minister flies to Moscow with a powerful delegation, a Russian spokesman said Tuesday.

Negotiations for Indonesia to obtain Russian military hardware have moved forward quickly since the Jakarta government canceled an agreement earlier this month to buy nine F-16 jet fighters from the United States.

BEIJING: Shanghai will freeze development of land in the city for non-farm uses this year in an attempt to revive its sagging real estate market, the newspaper China Daily reported Tuesday. A building boom has left

Shanghai with a surplus of empty office space and luxury apartments, forcing down rents and sale prices. Guangzhou, the capital city of Guangdong Province, which

borders Hong Kong, is to have

its own English-language news-

paper, an official report said Tuesday. The Guangzhou Morning Post will begin distribution July 1, the day Hong Kong reverts to Chinese control, the Xinhua News Agency reported.

HANOI: The central bank has ordered all commercial banks in Vietnam to submit detailed reports on overdue loans to help study the cause of the problem, state-run media reported Tuesday.

The reports must be submit-

ted by the end of the month. State Bank of Vietnam Governor Cao Sy Kiem was quoted as saying in the Economic Times.

SYDNEY: Chemical giant ICI was found negligent Tuesday over a pesticide that cattle producers said contaminated their stock, causing Japan, the United States and other nations to ban Australian beef in 1994.

Federal Court Justice Murray Wilcox found ICI was under a "duty of care" in connection with the manufacture and distribution of the pesticide chlorfluazuron (CFZ), sold under the brand name Helix.

Wilcox said in its haste for profits, ICI cut research corners and suppressed information that might have alerted "the dozing public watchdog." At a news conference, a

lawyer for the cattle producers, Peter Long, said: "It's clearly a case, I think, which will end up in the hundreds of millions of dollars."

WELLINGTON: The telecommunications company Swichtec has won a 16 million dollars (23 million New Zealand dollar) deal in Malaysia with a new cellular phone company.

Swichtec will supply directcurrent power supply systems for 1,000 cellular sites being installed by Telekom Malaysia's cellular subsidiary, which is installing a nationwide cellular network.
