Qualifications & Experience :

A. Botanist :
i) M.Sc in Botany with specialisation in Plant Taxonomy. ii) Must have experience in Plant survey methodology conducted by government/autonomous/reputed non-government organisation (certificates of such experience is to be attached with application. iii) Will and physical ability to undertake field work in remote forest areas under adverse situation. iv) Must have linkage with National Herbarium and/or Botany Department, Dhaka University.

B. Zoologist :
i) M.Sc in Zoology with specialisation in Wildlife Biology. ii) Must be conversant with fauna survey methodologies. Previous experience in faunal survey conducted by government/autonomous/reputed non-government organisation will be treated as added qualifications. iii) Will and physical ability to undertake field work in remote forest areas under adverse situation. iv) Must have linkage with wildlife section of Zoology Department, Dhaka University.

Duties :

A. Botanist :
i) Survey of flora in designated forest areas (taxa and families). ii) Identification of species — trees, shrubs, herbs, climbers creepers and others. iii) Quantitative data recording as per data format designed by consultants. iv) Assist in data entry.

B. Zoologist :
i) Survey of fauna (taxa and families) which includes mammals, amphibians, reptiles, Aves and other forms. ii) Identification of species. iii) Collection of samples if not identified. iv) Determination of population abundance. v) Data recording in data formats designed by consultants. vi) Compilation of list of endangered, vulnerable and threatened species. vii) Assist in data entry.

Duration of service : 03 months (extendable if necessary) from 15th July '97 (tentative).

Age : Maximum 30 years with good health.
