Bhuiyan condemns filing of case against Shawkat

BNP Secretary General Abdul Mannan Bhuiyan yesterday condemned the filing of "false and conspiratorial" case against Lt Gen (ret'd) Mr Shawkat Ali, reports UNB.

In a statement, he alleged that the government has been filing false cases against leaders and workers of BNP with ill motive to belittle the opposition before the people.

"The government has chosen the path of revenge after failing to face BNP politically, that has been proved through the filing of case against BNP Vice-Chairman Mir Shawkat Ali," he said.

Bangladesh envoy to Colombia presents credentials

The Colombian President Dr Ernesto Samper Pizano has lauded the steady growth of democracy and democratic traditions in Bangladesh under the wise and able leadership of Prime Minister Sheikh Hasina, according to a message received here from Washington yesterday, reports BSS.

Dr Ernesto S Pizano said this during the presentation of credentials to him by Bangladesh Ambassador to the USA KM Shehabuddin, who is also concurrently accredited to that country.

Colombian Foreign Minister Maria Emma Mejia-Velez was present in the presentation ceremony held recently in Bogota.

The Colombian President also identified some areas of cooperation between Bangladesh and Colombia after he was briefed by the Bangladesh Ambassador on the political stability, healthy growth of democracy, economy and liberal facilities for foreign investment in the country under the leadership of Prime Minister Sheikh Hasina.

Italian DFM due July 15

Italian Deputy Foreign Minister Toia is expected to pay a three-day official visit to Bangladesh from July 15, reports UNB.

During the visit, Toia will hold talks with State Minister for Foreign Affairs Abul Hasan Chowdhury on bilateral matters, particularly on expansion of trade and economic cooperation between the two countries.

Italy, one of Bangladesh's largest trading partners in Europe, purchases big quantum of leather, leather products and readymade garments from Bangladesh.

She is expected to call on other leaders and ministers.

Chief Justice leaves for Colombo

Chief Justice ATM Afzal left yesterday for Colombo to attend a regional symposium on the role of judiciary in accelerating development and expanding rule of law, reports UNB.

RCC mayor demands EPZ in Rajshahi

RAJSHAHI, July 2: A draft programme for making Rajshahi a healthy city was accepted at a daylong workshop held at BRAC auditorium here today, reports BSS.

Rajshahi City Corporation (RCC) Mayor Mizanur Rahman Minu opened the workshop organised by RCC in association with World Health Organisation (WHO).

The theme of the workshop was environment and health hazards in Rajshahi city. Dr Amanat Ullah Khan, consultant, WHO, presented the key-note paper at the workshop on 'healthy city Rajshahi programme'.

Alex Redekopp, sanitary engineer and team leader, WHO, in Dhaka, Sarit Datta Gupta, coordinator, healthy city Rajshahi programme, Dr Sultan Ahmed, a social worker, Kazi Farid Ahmed, deputy commissioner, Rajshahi, AKM Shamuddin, Rajshahi Metropolitan Police Commissioner, Abul Hashem, SP, Rajshahi, Col Zillur Rahman, Director, Rajshahi Medical College and Hospital, Dr M I Juberi, Professor, Department of Botany and Dr P C Sarkar, Professor, Department of Social Works of Rajshahi University, among others participated in the discussion. Three killed in separate incidents in Narayanganj

NARAYANGANJ, July 2: Three persons were killed here in separate incidents in the last two days, according to police.

Sonargaon police said, one Abdus Samad, 55, was killed by a gang of miscreants, led by one Majid, who borrowed money from the former. Samad was attacked when he was returning home from a nearby market at 6 pm on Tuesday.

He breathed his last while being taken to Dhaka at 2 am yesterday.

A close relative of the victim filed a murder case. One Sharif, aged about 18 was killed by some unidentified assailants near Bawa Jute Mills Tuesday night.

Bander thana recovered the body from a sugarcane field near the river Shitalakkhya this morning. Marks of injuries were found in his body. The father of the victim filed a murder case.

In another incident, a truck ran over one unidentified person near the Amiz Uddin petrol pump under Siddhirganj thana this afternoon. The person died on the spot.

Police sent three dead bodies to Narayanganj Sadar Hospital for autopsy.

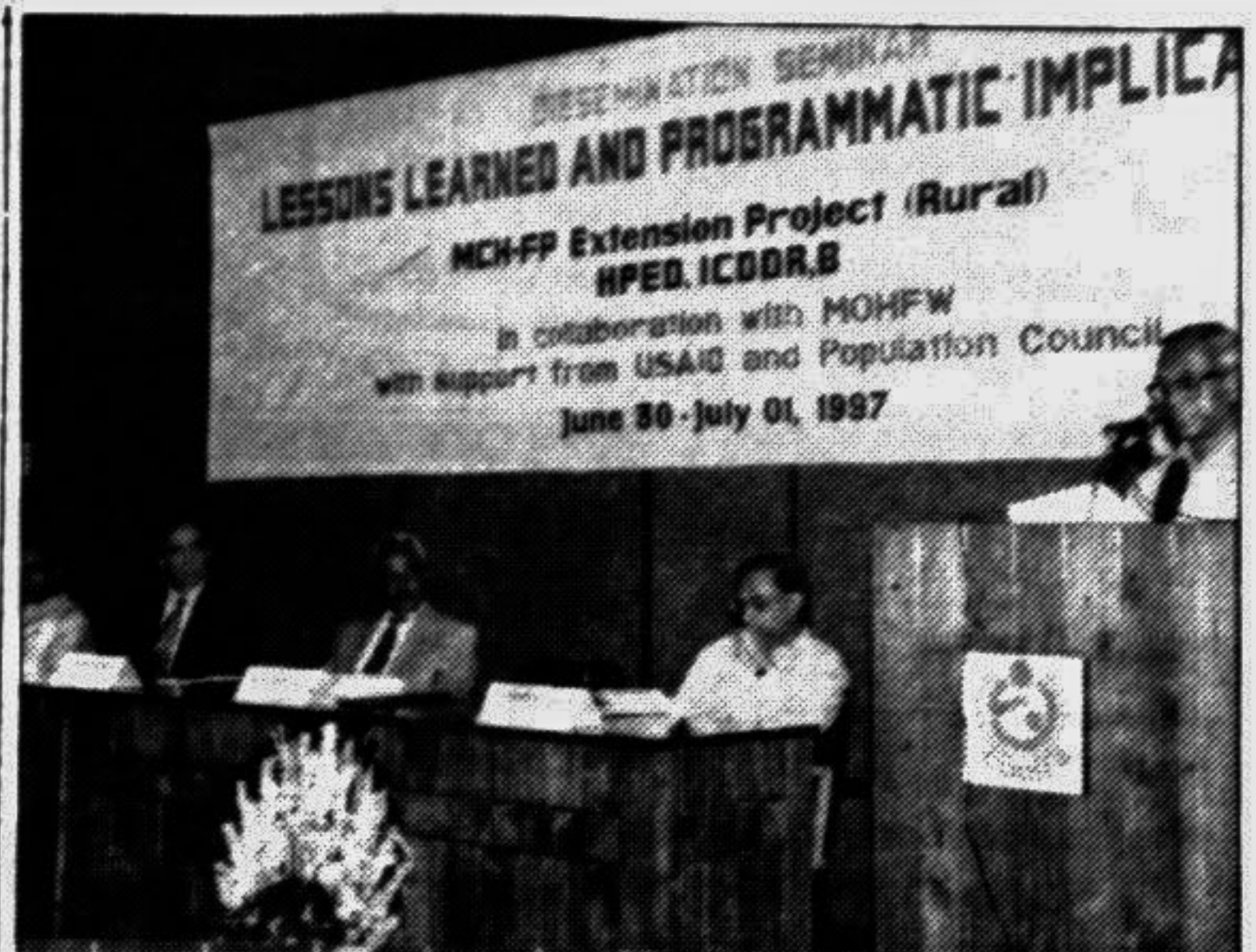
First Class First
