DCC procuring equipment to speed up road repair works

Dhaka City Corporation (DCC) is procuring equipment worth about Tk 38 crore to accelerate the road development and repairing works in the metropolis, reports UNB.

The equipment include 18 road rollers, 19 concrete mixture machines, 8 asphalt lifts and 12 dump trucks. Some of the equipment have already been brought while the rest are awaiting government approval

Of the total cost, Tk 27 crore will come as foreign aid while the rest from government assis-tance, said a DCC press release yesterday.

Most of the city roads remain in bad shape due to development and repair works done almost every year. Some roads become raised, some flat or low.

Mayor Mohammad Hanif directed the engineering department of the DCC to take necessary steps for repairing and levelling the roads with modern and sophisticated equipment. With the introduction of

these equipment in road repairing works, about 30 per cent materials of the pavement could be reused, cutting repairing cost and time.

Besides, the roads will be durable, their height will not increase and sewerage line and footpaths will not suffer any damage during the development


