Iswardi Poura chairman arrested

Drug addicts on rise

Local people said locally made wine, ganja, phensidyl syrup and other drugs are being sold openly at the market places and medicine shops by anti-social elements before the nose of the law enforcing agencies. A section of dishonest people have been making money taking advantage of the unguarded situation. The youths are increasingly being addicted due to the easy availability of drugs.

Shortage of veterinary doctors

PIROJPUR, Aug 27: The death rate of cattlehead and poultry birds is on rise in the district for lack of cattle fodder, adequate medicine and requisite number of veterinary doctors, reports

Local people complained that many cattlehead and poultry birds in six thanas of the district are on the verge of extinction due to the outbreak of various diseases and lack of treatment facilities. Besides, supply of cattle and poultry fodder are also inadequate and costly in the local market. According to an official source, one livestock official and two veterinary doctors as per rule are to be posted in each thana but most of the posts are lying vacant since long in many thanas.

Shamima Khatun, 22, Arab Ali, 35, Shaheb Ali, 32, Yad Ali, 24, Babul, 27, Faridul 20, Sufia Khatun, 65, Nur Begum, 40, Shanti, 14, Rikta, 11, Ashraful, 16, Nazma, 27. Emotaz, 30, Momena, 24, and Rokcya Khatun, 35.

When contacted Executive Engineer of Public Health Engineering Department (PHED) said he has also scaled off one tubewell in Khoksa thana, 4 in Kushtia town, one in Jogoti union and one in Daulatpur thana.

In Kushtia town, 6 persons have already been attacked with various diseases. They have stopped taking water of those tubewells. Their condition has been stated to be improving.


