DCC may start repairing city roads within two weeks

By Staff Correspondent Dhaka City Corporation (DCC) is to start repairing city roads within the next two weeks if the sunny spell prevails, acting chief engineer, Shafiul Islam said.

The engineering section has already written to different utility services in the city, including Titas Gas, WASA, T&T and DESA, to provide the section with a list of works they might undertake in the city.

"We will make sure that none digs up the roads after we have completed the costly repair works," Islam said. The engineering section has also warned the utility services that they would not be allowed to dig the roads later if they do not get listed now.

The chief engineer said the damage to city roads, due to incessant rain, could cost up to Taka 150 crore to repair. "But now we have Tk 48 crore in our fund, with which we will start the work," said Islam adding that about Tk 70 crore was in the pipeline.

Islam also confirmed that he would personally make sure that good standard of work is maintained during the repair works. A strict monitoring would be observed, he said.
