By Staff Correspondent A six-year-old boy drowned and two others including a housewife allegedly committed suicide in the last two days in the city.



Earlier police took position on the road adjacent to the BNP office and got inside it when the workers of the BNP and its front organisations were preparing to hold a protest rally against the removal of the floating bridge.

The bridge was removed late Wednesday night.

Following angry exchanges between the BNP leaders and police on the issue of entry of police personnel into the party offices, activists of the party chased the policemen out of the building. Soon after, clashes erupted in the BNP office area with police firing teargas shells and BNP activists brickbatting

Police lobbed teargas shells at the activists inside the BNP office and in the lanes and bylanes around it. The activists threw brickbats and exploded

crackers. Several hundred party leaders and workers were trapped

inside the BNP office at the Later clashes spread all over the area from Kakrail to Fakir-

erpool, halting traffic movement on the Inner Circular Road and forcing closure of shops and business establishments. Panic prevailed in the locality. Earlier, the agitated BNP ac-

tivists damaged some vehicles plying through the area, witnesses said.

Pitched battles between the police and BNP workers continued for several hours and the situation there remained tense till 8 pm.

BNP chief and Leader of the Opposition in Jatiya Sangsad Begum Khaleda Zia reached the party office in the evening when tear gas smoke still clouded the party office and its surrounding areas. She later addressed a hur-

riedly-called press conference to condemn the police action. She also announced a three-day demonstration programme from today.

Meanwhile, the Dhaka Metropolitan Police (DMP) in a press release said BNP leaders

and workers started preparing for a public rally on the road in front of the party office, without taking permission from the Dhaka City Corporation. They also set up a public address system there.

Cleansers with lipo protein

The leaders turned down the police request not to hold the rally without permission and for the sake of normal movement of vehicular traffic and misbehaved with the policemen on duty, the press release added.

At one stage, it added, BNP activists there started pelting brickbats and exploding cocktails and petrol bombs, stored in the BNP office. In the incident, a police surgeon and two constables were injured. In such a situation, police was forced to intervene to bring the situation under control.

Police picked up 22 persons from the spot, the DMP said. It urged all concerned to refrain from holding public gatherings on the city streets.

His funeral was to be held Friday in Kathmandu and tens of thousands of people were expected.

Born in 1915 in Kathmandu, Singh studied in Calcutta and joined the Nepalese resistance to the ruling Rana family after a clash with young members of the Ranas who said he had not right to ride a horse.

Singh played a key role in the overthrow in 1951 of the Rana family, who pursued a policy of close cooperation with the British in India, and had ruled Nepal since 1846.

One of the founders in 1949 of the Nepali Congress, which remains a key force in the Himalayan Kingdom's politics, Singh spent long periods in jail under the Rana rule and again when the monarchy, which took over after 1951, imposed personal rule.

When the parliamentary system was dissolved in December 1960 by King Mahendra, Singh was imprisoned for eight years along with almost all NC leaders. On his release in 1968, Singh

went into exile in India for two years, on his return he was rearrested and imprisoned until Sing also played a signifi-cant role in the 50-day people's movement which culminated in


