**Call to uphold teachings of Begum Rokeya**

Food and Agriculture Minister Matia Chowdhury yesterday called for upholding the ideals and teachings of Begum Rokeya Shakhawat Hossain to establish equal rights of men and women in society, reports BSS.

The minister was addressing the 'Begum Rokeya Smriti Padak-97 presentation ceremony at the Home Economics College auditorium in the city.

Presided over by the president of 'Begum Rokeya Smriti Sangsad', Prof. Dr. Ayesha Khatun, the function was addressed, among others, by education advisor to the former caretaker government Prof. Shamsul Haque Vice-Chancellor of Jahangirnagar University Prof. Amirul Islam Chowdhury, Meherunnesa Islam, Momena Khatun, acting principal of Home Economics College Prof. Shamsunnahar, Secretary of the Sangsad Rezaul Karim Manju and Mazeda Saber.

Matia Chowdhury said Rokeya demanded equal rights of women as human beings through her writings more than a hundred years back.

"We have failed to disseminate the thoughts and teachings of Begum Rokeya to the common people of the country," Matia said.

Begum Rokeya educated herself during the dark age of 18th century and established educational institutions for girls. But the actual literacy rate of the women in our country is only 16 per cent now, which reflects very minor progress of the country," she said.

Regretting dowry, the minister said, "We have failed to raise our voice to protest discrimination, oppression and repression on women, the way Rokeya did hundred years back."

"She said, 'We want to live in the society as human beings not as women.'"

Prof. Shamsul Haque said Begum Rokeya had set up an example for us to educate the underprivileged women and men of our society through her unparalleled courage.

Prof. Amirul Islam Chowdhury said Begum Rokeya was the product of Bengal renaissance.

Meherunnesa Islam and Momena Khatun, former teachers of Begum Rokeya Shakhawat Memorial Institute in Calcutta, spoke on the life and works of Begum Rokeya.

Later, Matia Chowdhury distributed medals, crests and certificates among selected students of Home Economics College and Dhaka University.
